Topics where; Keizer Station Master Plan D

This matter is before the Council for public hearing to consider an amendment to the Area D Master Plan. The property in question is Keizer Station Area D (Commerce Center) and is located at the Chemawa/Interstate 5 interchange. This amendment will modify the previously approved plan by changing the location and number of buildings and uses, overall parking lot layout, and landscaping features in the area south of Ulali Drive. The original approval provided for a total of eight buildings with a gross leasable area of 87,975 square feet to be developed with a mix of retail, office, and flex-industrial uses. The proposed amendment will reduce the gross leasable area to 72,535 square feet and will include six buildings and a drive through coffee kiosk. Most of the proposed uses will involve eating and drinking uses, along with some retail, a car wash, tire sales, and hotel tenant. No changes are proposed to the northern side of Ulali Drive.

- > We looked at the impact it may have since we have Verda Crossing going in as well.
- > Tammy shared it just adds more resources to our community for growth with work, depending on what goes in.
- ➤ Opportunity for more families to join us and work on growing the Association these Ladies work so hard. (AL)

Eduardo shares we have been in existence for 14 months now and shares some of the things we have been able to accomplish; 2 back to school events, 2 community café's within the school for the topics of Trauma informed and Strategies and Power over our Cultural Habits both having more than one day, One in Spanish and one in English. Supporting the after school Summit program, for the school year 2021 to 22 and then for 23 to 24 school years for Kennedy Elementary school.

Going back to Oct; we support Parent club and not have to do the planning and leg work November; Thanksgiving baskets for families and or Staff (November \$1,500 I'm envisioning like a book chocolate candy cane something for every student; Eliza)

December events to be held in January as we did last year to allow more time and planning (\$2500.00 gift; \$1500 purchases from end of Dec 23; adding \$1000.00 for January budget) the total of \$5000.00.

Update; from the summer program; Eliza

Stem/Art projects; Water colors painting, Kindness rocks, Friendship bracelets just to name a couple. Then with the reading program 10 to 20 students per week were able to access books and resources. Service project; Library Beatification project, Wallpaper shelves, Bilingual Painting, Cool down Zone and end of summer treats. We awarded \$300.00 for this and success was achieved!

Tammy and Jacqueline Partner with KNFC as they are both part of this group as well, but got 17 people in the community to come to the schools and help serve food, games were played, Frames done and much more. Way to go ladies!

October 2023

Oct we met twice the 1st meeting was our board meeting and we posted this on our websites, and sent out emails.

The board covered a number of items we started with the lack of interest in in person meetings since we have around 20 to 35 in online meeting. This seems to fit the families and I am sure the cold weather plays a role in this as well. We decided to host meeting online and us google meets, Judy helped to set that up she is out newest member. Judy has 5 kiddos so making time is very hard, she asked if we could do a meeting in the afternoons and Tammy and Jacqueline said they are willing.

So while Tammy had her infusion at Salem Hospital we hosted a meeting from 12:30 to 1:30 to allow families time to pick up kids from school. We heard from 5 people concerns on traffic as renting is opening up at Verda crossing. Bill asked if we could get a crossing guard program together to help with the safety of our kids to and from school. We had 4 people say they would help with this.

Next item was ways to outreach or rebrand the Association to gain more connections with the community. Tammy and Jacqueline shared rebranding may take away from what we have built and to look at doing a different outreach. Meg said flyers add more color, and maybe use food to help bring families in. Potluck every other month, to help gain more support. Tammy is not sure of the paperwork we would have to do with the community center for this. We spent some time going over ideas and ways to meet but also to help meet families were they are. Plus, reminder the holidays are coming, and people get really busy.

We all agreed to use the online forum for right now and build this way as it seems to meet the needs of our community.

2nd meeting Oct 25th 11 am to 11:30 am

We did a check in to see how the online setting worked surprised we had 25 people so it was a huge success and we will do the same for Nov and Dec to see what happen for the busy months. We had 15 attend this meeting and they are good with the online setting and it helps them be involved but not take time from families at night. They also like the different times so kids are still at school and they can still be part of and meet the needs for the families. This meeting was only 30 minutes just to check in and see what people had to say and find out if this was better or worse.

Everyone was happy to do the online setting, the only feedback was format and finding one that we could use all the time and stick to that. Google meets was one everyone like and Tammy asked if we could use this for the next couple of meeting and then see what we think.

Jacqueline asked if we could take notes of things we would like to see happen and topics to cover, we all agreed the new Verda crossing was high on the list and lack of sidewalks for our kids.

We also shared our concern that city council may not like the online setting and have to go to in person meeting and what that would look like as most of us could not come out in the evening do to sports, band, and other school activities. This setting allows us to be part of what is going on and allow Tammy and Jacqueline to share what happen in the meetings at City Hall. Tammy understood the concerns and shared we can use this format as long as we take minutes and inform the community. But she will look at this more.

Hello,

How / why did I get involved in the Neighborhood Association?

I talked to Carol and asked questions, and Rhonda from West Keizer Neighborhood Association, as well as Colleen/ Bob from Southeast Keizer Neighborhood Association and they shared it a great way to have support for the neighborhood. We have some issues to deal with and I decided to take this on.

The Neighborhood Association primary contact is a volunteer that a recognized Neighborhood Association selects to serve as their primary contact with the City of Keizer. The Neighborhood Association contact serves as the primary communicator between the recognized neighborhood association and the City. Contact information for this individual is available to the public on the City's website and upon request. All City Staff will be notified of the name and contact information for the Neighborhood Association. City Staff will be able to assist the contact to interpret official notices and policies.

Do I consider myself an activist? No, I just advocate for what we need in the community and what I hear from my community. The City will seek to notify the Neighborhood Association contact on matters of neighborhood interest. For example, the Neighborhood Association contact will be notified when: Significant neighborhood projects are being discussed or proposed such as street reconstruction, park development or redevelopment or land use planning.

•A mailing goes out to residents in the neighborhood related to a City matter or public hearing.

The Mayors Proclamation for October; I am part of the Community Diversity Engagement Committee and I asked to do this for the Committee. It's a way for us to share this information within the community and shine a light on things people don't know or understand. I love serving the community this way, as I am not used to being front and center but to help bring awareness to a cause like this warms my heart.

What are 3 issues Greater Northeast Keizer faces? The top 3

- 1. Northview Terrace is in need of a bathroom for our children to use, while we play at this park, they would like one that is handicap accessible.
- 2. Sidewalks are vital to achieve safety for our children getting to and from school. I am going to be working with Safe route to schools as well on how we can achieve this. Kennedy Elementary is in need of sidewalks to allow our kids a safe route to school.

3. Verda Lane Project; information comes from attending meetings may be subject to change as the project moves forward. The side walk on the Verda crossing side is almost complete. Cherriots was there on September 1st assessing the bus stops to see what changes need to be made on their side.

Question that have come about; Verda Lane: Dearborn Avenue to Salem Parkway Design Phase; Verda Lane is a route used by both Elementary and Middle/ High school students. We will have the following.

- Construct bicycle lanes.
- Build sidewalks.
- Realign intersections.
- Upgrade drainage- The drainage is being addressed by the road side they added good size drainage and are adding rock and dirt to that area to help hit off the flooding for raining season.

On the scale of 1 to 10 city of Keizer does working with the Neighborhood Association? For the most part the Council / And Keizer are supportive of the Associations and we are currently working on updating Ordinance so that we can be more effective with the work we do in the community. I would rate it at a 9 as we could use more support from all our Keizer folks in Charge.

What is my background? And are you a member of other organizations? I am a compassionate person, one who cares about the wellbeing of others. I know how to help people find hope or inspiration to overcome obstacles because I had to do it to get this far. I am capable of providing encouragement to those who needs extra help in finding their own inspiration to reach their own goals.

I am confident in my abilities to perform the duties of this position partly because I have been through the mill and acquired my GED, as well as two Associates degrees in Elementary Education and Business Administration. I graduated with Honors in my business degree and am having a Bachelor in Business Administration with a minor in Project Management. I did this while going to school online, even being homeless I was able to do degree program online work and not fall behind. This shows my determination to complete what I start. I love serving the community in any way I am able to. I have attended all the meetings for a while now and have seen how things work. I believe I can make a difference in our community and the committees I serve on. I have been attending other inter-governmental meeting as well as become part of the community in a meaningful way. I take pride in how I interact with my families and those around our City, and State. I have worked very hard to learn from my leader and have become more active with in the community on multiple levels.. I have been worked hard to create Greater Northeast Keizer Neighborhood Association as well as the Neighborhood watch program with our Police department and for Northeast

Keizer as well as all of Keizer. This is for the Kennedy Neighborhood Family Council has been up and running smooth for 18 month, which serves the same School as our Association. I work closely with you and the parents of this community to make this a safer place for our children to grow up in.

The basic ingredients are people who are willing to work together to create change. Planning and structure people who are will to be a leader or hold a leadership position. Neighborhoods are the heart of a city. For many people, the neighborhood they live in is as important as the house they live in. Most neighborhoods have clearly identifiable characteristics: housing types, appearance, neighborliness, and safety. These characteristics affect the value of the houses in the area as well as the desirability of living in the neighborhood. Meeting on the 5th online forum; from 3pm to 4pm

We had 23 people attend 6 new families to be involved in this meeting. We did a small Q/A in the beginning after introductions.

Tammy led this topic;

A neighborhood association is a group of homeowner, renters, apartment dweller and churches, businesses, Schools and representatives who want to improve their neighborhood. I helped to put this neighborhood association together in order to help improve the condition of my community and those communities around me. We are just a group of people who want to create change in our communities and make it safer for our children and grandchildren and for ourselves.

The basic ingredients are people who are willing to work together to create change. Planning and structure people who are will to be a leader or hold a leadership position. Neighborhoods are the heart of a city. For many people, the neighborhood they live in is as important as the house they live in. Most neighborhoods have clearly identifiable characteristics: housing types, appearance, neighborliness, and safety. These characteristics affect the value of the houses in the area as well as the desirability of living in the neighborhood. There are both emotional and economic benefits to having friendly, safe, and attractive neighborhoods.

Jacqueline led another Q/A for Neighborhood Watch seems like tagging in some of our areas on fences is making a comeback.

The prevention of crime – particularly crime involving residential neighborhoods – is a responsibility that must be shared equally by law enforcement and private citizens. The fact

is, the impact on crime prevention by law enforcement alone is minimal when compared with the power of private citizens working with law enforcement and with each other.

NEIGHBORHOOD WATCH is based on this concept of cooperation, and nationwide statistics prove that it works. When citizens take positive stops to secure their own property and neighbors learn how to report suspicious activity around their homes, burglary and related offenses decrease dramatically.

People seemed to want to know more. Jacqueline Asked if in person meeting would work but a few said they want to stick with the online setting as they can attend during lunch for work, take care of the family needs and beware of the community needs and that they would be involved in done online as it fits with the growing family needs.

Tammy Led this conversation with the families; Adding to the board of directors She has 4 people who would join the board of the online forum stays in place, one mom(Beth says she care for 5 kids and 1 whom has special needs) this is the only way for right now sees how she can add support. One of the other dads is looking to be involved but needs to talk to his wife to see what that would look like, Don expressed interest in the neighborhood watch side to ensure his family and neighbors are safe. Don Said he would also like to build take a book leave book boxes 6 per year, and some for our parks so we can share books at the parks and our neighborhood Association information by making boxes for this information. Don is going to see if his wife would like to join the board.

This was really good conversation with the community and the online setting really seems to fit. I know for me Ashley it works great, I work 2 jobs and have 3 kiddos and they keep me busy, but attending this meeting has become important and I enjoy filling in for taking minutes. But am grateful there are 2 of to do this so if I am unable to for sporting event or another reason Becky is able to do this as well. So from Becky and I thank Tammy and Jacqueline for going over and above what most people would do.

Community Cafés are in works with Kennedy Neighborhood Family Council as we both serve the same school. We do have a trauma informed and having difficult conversions one in English and one is Spanish Thursday 15^{th to} be held at Kennedy Elementary.



Celebration of Women in Service

We have some amazing women in our local government that serve you. We have Shaney Starr, Laura Reed, Keizer Library staff and Keizer Chamber of Commerce staff, GNEKNA Neighborhood Association (Jacqueline Green, Tammy Kunz) West Keizer Neighborhood Association as well as others. These ladies work within Keizer to make Keizer better place for our families.

February is black history Month;

As we look back let's remember how we started and look how far we have come.

The earliest known person of African descent was Markus Lopeus, a Black sailor who arrived at Tillamook Bay with merchant sea captain Robert Gray in 1788. It is documented that Lopeus died during a dispute with local Native Americans. In the following years, Black fur trappers and explorers came to the region. Many worked for the Hudson's Bay Company. A few led some of the first emigrant wagon trains over the Oregon Trail. But as more and more white settlers arrived in the area, they brought their own laws and prejudices with them.

In the 1840s, the region's provisional government forbids slavery, while also banning Black people from settling in the area. When Oregon became a state in 1859, it was the only state admitted to the Union with an Exclusion Law in its constitution. That law remained until voters removed it in 1926, while the original racist language stayed on the books until 2002.

"Oregon's Black Pioneers" explores the stories of the African-Americans who lived, worked and created communities despite the hardships. People like Robin and Polly Holmes, who sued their former owner for their children's freedom; Letitia Carson, who successfully took a wealthy landowner to court after he stole her property; and James Douglas, who spent twenty years helping run Fort Vancouver before becoming the governor of Vancouver Island and British Columbia.

You can learn more about this through the Keizer Heritage Center.

March is Women History Month;


Oregon is known for strong Women to lead the way for so many as women over the years.

We have Beatrice Marrow Cannady who helped lead the Civil rights movement and quickly became known for her activism as the co-owner of NAACP's Branch in the early 1900's.

Thelma Payne for sporting events in the swimming and dive sectors. She went on to break records in the summer of 1920.

Celebración de las Mujeres en Servicio

Tenemos algunas mujeres increíbles en nuestro gobierno local que le sirven. Contamos con Shaney Starr, Laura Reed, personal de la biblioteca de Keizer y personal de la Cámara de Comercio de Keizer, la Asociación de Vecinos GNEKNA (Jacqueline Green, Tammy Kunz), la Asociación de Vecinos de West Keizer y otros. Estas mujeres trabajan dentro de Keizer para hacer de Keizer un mejor lugar para nuestras familias.

Febrero es el mes de la historia negra;

Al mirar atrás, recordemos cómo empezamos y miremos hasta dónde hemos llegado.

La primera persona de ascendencia africana conocida fue Markus Lopeus, un marinero negro que llegó a la bahía de Tillamook con el capitán del barco mercante Robert Gray en 1788. Está documentado que Lopeus murió durante una disputa con los nativos americanos locales. En los años siguientes, cazadores de pieles negras y


exploradores llegaron a la región. Muchos trabajaron para la Compañía de la Bahía de Hudson. Algunos condujeron algunas de las primeras caravanas de emigrantes por el sendero de Oregón. Pero a medida que llegaron más y más colonos blancos a la zona, trajeron consigo sus propias leyes y prejuicios.

En la década de 1840, el gobierno provisional de la región prohibió la esclavitud, al tiempo que prohibió a los negros establecerse en la zona. Cuando Oregón se convirtió en estado en 1859, era el único estado admitido en la Unión con una Ley de Exclusión en su constitución. Esa ley permaneció hasta que los votantes la eliminaron en 1926, mientras que el lenguaje racista original permaneció en los libros hasta 2002.

"Los pioneros negros de Oregon" explora las historias de los afroamericanos que vivieron, trabajaron y crearon comunidades a pesar de las dificultades. Personas como Robin y Polly Holmes, que demandaron a su antiguo dueño por la libertad de sus hijos; Letitia Carson, quien llevó exitosamente a los tribunales a un rico terrateniente después de que le robó su propiedad; y James Douglas, quien pasó veinte años ayudando a administrar Fort Vancouver antes de convertirse en gobernador de la isla de Vancouver y Columbia Británica.

Estas son solo algunas mujeres en Oregon que ayudan a marcar el camino para cada persona que ha seguido esos pasos.

City Council Update; Discussion regarding Gas and Electric Franchise Agreements

Zachary Sielicly, Government Affairs Manager with Northwest Natural, stated that they have a resource center on Broadway and spoke about a streamlined permit process for working in right-of-ways and how a franchise creates stability. He asked that the Council support their Franchise Agreement.

Wendy Veliz, Portland General Electric (PGE), spoke to seek the Council's approval for a Franchise Agreement with PGE. She provided statistics for PGE's services and stated that PGE shared services with the City of Keizer by utilizing public right-of-ways. PGE asked that the Council move forward with staff's recommendation to agree with a Franchise Agreement. She confirmed that the standard, best practice is a ten-year contract with an auto-renewal of five years.

Tony Schacher, Salem Electric, summarized the number of members that they serve and the history of electric service. He stated that a Franchise Agreement instead of a right-of-way ordinance was a much more suited means to regulate their use within the right-of-way, although having both would likely strengthen the City's ability to regulate right-of-way use to meet its needs.

Garden in a Glove Activity - 5 Steps for a Garden in a Glove

- STEP ONE: Line up 5 cotton balls and rip them in half.
- STEP TWO: Label each finger with the name of the seed.
- STEP THREE: Add the appropriate seed to each labeled finger. ...
- STEP FOUR: Spray each finger with water.
 STEP FIVE: Name your garden, blow air into the glove and tie with rubber band.

To begin, let's highlight some of the fentanyl!

"Fentanyl is a human-made opioid used to treat severe pain. It's 50 to a 100 times stronger than morphine" (Benisek). We are seeing fentanyl in various different forms including powder, liquid/intravenous, candy, and laced onto other drugs. Furthermore, we are coming across Fentanyl that could appear to look like oxy pills known in schools as fake M30 tablets, perc 30's, blues, dirty 30's, etc. These are pills manufactured at a street level that are made to look like Oxy. Other forms to pay attention to are fake Xanax bars aka "bars "or "school buses", fake ecstasy pills, etc.

Communities, school districts in rural and large areas, along with parents are going to need to increase their education on fentanyl and other dangerous drugs in order to prevent the rising numbers of students using and experimenting with these various substances. Local and state policy alone cannot curve the trend we are seeing today. Educating people will only motivate the efforts for change in this chronic issue. As we focus this article on fentanyl, please keep in mind other opioids, methamphetamine, vapes and benzodiazepines are also

trending at high level levels in various communities.

Keizer City Parks and Keizer Rapids Park Turf field

There was discussion regarding the goal of a City-wide camera system and Page 174 of 177 Keizer City Council Work Session Minutes Monday, January 22, 2024 – Page 2 the potential costs, including the ongoing annual expense. There was a question about how much of a cost-savings there would be from the help of deterring crime and solving cases. Cameras would be in the parks, at road exits from the City, as well as Police Body Cameras. The upfront costs were estimated to be \$500,000 plus the cost of power and \$75,000 for the Police Body Cameras.

The Artificial Turf Project was bid and awarded, and the construction was scheduled to begin in the Spring for the first Phase. It would cost approximately \$1 million to finish the parking lot and equipment building. The City would be applying for a grant for the bathroom. There was discussion about partnerships, potential sponsorships and future use of the fields.

This is to help cut down on the tagging all the parks are experiencing and hopefully provide a safer community for our families. More to come if you see tagging you can go on line and file a report with pictures the city staff works really hard to get that cleaned up fast.

Abril y mayo de 2024 Actualización del Ayuntamiento; Discusión sobre Contratos de Franquicia de Gas y Electricidad

Zachary Sielicly, Gerente de Asuntos Gubernamentales de Northwest Natural, afirmó que tienen un centro de recursos en Broadway y habló sobre un proceso de permisos simplificado para trabajar en derechos de paso y cómo una franquicia crea estabilidad. Pidió que el Consejo apoye su acuerdo de franquicia.

Wendy Veliz, Portland General Electric (PGE), habló para buscar la aprobación del Consejo para un acuerdo de franquicia con PGE. Proporcionó estadísticas de los servicios de PGE y afirmó que PGE compartía servicios con la ciudad de Keizer mediante la utilización de derechos de paso públicos. Palabras del alcalde Clark compartidas en el Concejo Municipal La alcaldesa Clark revisó las

Me gusta usar rollos de papel higiénico para plantas que tienen sistemas de raíces largas, como calabacines y judías verdes, la mayoría de mis plantas enredaderas. Empiezo de esta manera, cavo un agujero y coloco el tubo completo en el interior, ya que agrega soporte y se degrada, ayuda al suelos. Actividad de jardín en un guante: 5 pasos para un jardín en un guante • PASO UNO: Alinee 5 bolas de algodón y córtelas por la mitad. • PASO DOS: Etiquete cada dedo con el nombre de la semilla. • PASO TRES: Agregue la semilla apropiada a cada dedo etiquetado. • PASO CUATRO: Rocíe cada dedo con agua. PASO CINCO: Nombre su jardín, sople aire en el guante y átelo con una banda elástica

Para empezar, ¡destaquemos algo del fentanilo!

He tenido MUCHAS conversaciones con administradores escolares, SRO y representantes del departamento de salud local que han destacado las sobredosis de fentanilo en sus escuelas. Las escuelas secundarias tienden a ser las más comunes. Los adolescentes de todo el país están obteniendo cada vez más acceso a diferentes sustancias y vemos diferentes tipos de estas drogas todos los días. Incluso más recientemente, se ha informado de la presencia de fentanilo mezclado con marihuana en algunas escuelas secundarias. Pero eso no significa que las escuelas intermedias o incluso primarias no verán un aumento.

Para empezar, ¡destaquemos algo del fentanilo! "

El fentanilo es un opioide de origen humano que se utiliza para tratar el dolor intenso. Es entre 50 y 100 veces más fuerte que la morfina" (Benisek). Estamos viendo fentanilo en varias formas diferentes, incluyendo polvo, líquido/intravenoso, caramelos y mezclado con otras drogas. Además, nos estamos topando con Fentanilo que podría parecerse a pastillas de oxi conocidas en las escuelas como pastillas falsas M30, perc 30, blues, dirty 30, etc. Se trata de pastillas fabricadas a pie de calle que están hechas para parecerse a Oxy. Otras formas a las que hay que prestar atención son las barras falsas de Xanax, también conocidas como "barras" o "autobuses

escolares", las pastillas de éxtasis falsas, etc. Las comunidades, los distritos escolares en áreas rurales y grandes, junto con los padres, necesitarán aumentar su educación sobre el fentanilo y otras drogas peligrosas para evitar que un número creciente de estudiantes usen y experimenten con estas diversas sustancias. Las políticas locales y estatales por sí solas no pueden frenar la tendencia que estamos viendo hoy. Educar a la gente sólo motivará los esfuerzos por cambiar este problema crónico. Mientras centramos este artículo en el fentanilo, tenga en cuenta que otros opioides, la metanfetamina, los vaporizadores y las benzodiazepinas también tienen una tendencia a niveles altos en varias comunidades. ¡El cambio comienza contigo! ¡Ayuda a Educar a quienes podamos!



Hello,

How / why did I get involved in the Neighborhood Association?

I talked to Carol and asked questions, and Rhonda from West Keizer Neighborhood Association, as well as Colleen/ Bob from Southeast Keizer Neighborhood Association and they shared it a great way to have support for the neighborhood. We have some issues to deal with and I decided to take this on.

The Neighborhood Association primary contact is a volunteer that a recognized Neighborhood Association selects to serve as their primary contact with the City of Keizer. The Neighborhood Association contact serves as the primary communicator between the recognized neighborhood association and the City. Contact information for this individual is available to the public on the City's website and upon request. All City Staff will be notified of the name and contact information for the Neighborhood Association. City Staff will be able to assist the contact to interpret official notices and policies.

Do I consider myself an activist? No, I just advocate for what we need in the community and what I hear from my community. The City will seek to notify the Neighborhood Association contact on matters of neighborhood interest. For example, the Neighborhood Association contact will be notified when: Significant neighborhood projects are being discussed or proposed such as street reconstruction, park development or redevelopment or land use planning.

• A mailing goes out to residents in the neighborhood related to a City matter or public hearing.

The Mayors Proclamation for October; I am part of the Community Diversity Engagement Committee and I asked to do this for the Committee. It's a way for us to share this information within the community and shine a light on things people don't know or understand. I love serving the community this way, as I am not used to being front and center but to help bring awareness to a cause like this warms my heart.

What are 3 issues Greater Northeast Keizer faces?

The top 3

- 1. Northview Terrace is in need of a bathroom for our children to use, while we play at this park, they would like one that is handicap accessible.
- 2. Sidewalks are vital to achieve safety for our children getting to and from school. I am going to be working with Safe route to schools as well on how we can achieve this.

 Kennedy Elementary is in need of sidewalks to allow our kids a safe route to school.
- 3. Verda Lane Project; information comes from attending meetings may be subject to change as the project moves forward. The side walk on the Verda crossing side is almost complete. Cherriots was there on September 1st assessing the bus stops to see what changes need to be made on their side.

Question that have come about; Verda Lane: Dearborn Avenue to Salem Parkway Design Phase; Verda Lane is a route used by both Elementary and Middle/ High school students.

We will have the following.

- Construct bicycle lanes.
- Build sidewalks.
- Realign intersections.
- Upgrade drainage- The drainage is being addressed by the road side they added good size drainage and are adding rock and dirt to that area to help hit off the flooding for raining season.

On the scale of 1 to 10 city of Keizer does working with the Neighborhood Association?

For the most part the Council / And Keizer are supportive of the Associations and we are currently working on updating Ordinance so that we can be more effective with the work we do in the community. I would rate it at a 9 as we could use more support from all our Keizer folks in Charge.

What is my background? And are you a member of other organizations?

I am a compassionate person, one who cares about the wellbeing of others. I know how to help people find hope or inspiration to overcome obstacles because I had to do it to get this far. I am capable of providing encouragement to those who needs extra help in finding their own inspiration to reach their own goals.

I take pride in how I interact with my families and those around our City, and State. I have worked very hard to learn from my leader and have become more active with in the community on multiple levels..

I have been worked hard to create Greater Northeast Keizer Neighborhood

Better sidewalks, more connections with people in the community and build more ways to engage within the community. Safer ways to cross streets, better lighting for parks and more ADA parks for those families who need them are some of what can we do to make Keizer safer and better.

Meeting minutes March 5th online Meeting 15 attendance

Tammy and Jacqueline reached out to share that we were not going to host our in person meeting this month. We reached out to have a brief discussion on using our online Google meet. I want you all to know until I share this with Tammy and Jacqueline they do not know what is in this and the board is aware we are doing this we have their blessing.

Here's why, Tammy had been holding community conversations online with Next-door and Facebook. She had asked what engagement we are looking for from the Association and Community Diversity Engagement Committee here are some of those highlights.

Four popular community engagement methods are community meetings, focus groups, surveys and online engagement – and there are pros and cons to using each one.

• Community meetings; Public or Town Hall meetings can be a valuable way of sharing information.

The face-to-face nature of these events provides a great opportunity to demonstrate openness and transparency to community members. It is important to consider what will make your event compelling to partnership with the communities – and encourage attendance.

With that we have families and some of us are single moms and dads, we have grandparents raising children and a small group of people who have survived abuse from our partners. For safety reasons cannot be on TV. (City Council and other meetings show feeds).

- Opportunity to deliver information and gather feedback. Community meetings can be used effectively at the beginning of an initiative to explain processes and outcomes. For this we rely upon Tammy and Jacqueline to help keep us safe while sharing information.
- Great for meeting community members in person, and to demonstrate transparency.
 For this we Thank Mrs. Starr, Mrs. Cross and Mayor Clark always show integrity and grace to make sure our voices are heard. Mr. Dan Kohler is the same. We don't have more money for this or that. We have a home with 4 generations living in one house with 3 bedrooms just because 2 of them became homeless and can't make it on their If an issue or project is particularly controversial, this may not be the right method for engagement.

- Media publicity may be negative if the meeting is confrontational or not handled well.
 Own right now.
- Can be useful for community outreach or to attract media attention for your project or program. We have watched and listened to the work session with the Traffic Safety Committee and know some of those people think we don't matter because we don't want to talk to our neighbors or knock doors. (it is not safe)
- This small group setting is an efficient way to use resources and identify important issues.
- Focus groups can be planned and organized to reach a specific group of community members and leaders that have developed around a particular topic. This is where Tammy and Jacqueline reached out and asked questions and looked at ways they can make a difference. They have surveys and done polls to see what makes a difference for us, meeting us where we are.

There is not one perfect way to engage with stakeholders, and needs will change depending on the groups and issues needing to be addressed. Using more than one outreach method for your engagement process will pave the way to increased stakeholder participation, and building of stronger relations with your neighborhood, online community. THIS THEY DO WELL

Being asked to participate in a consultation, but not believing that your input will make any difference to the outcome, is a serious hazard. If intention is not genuine, people can sense it. Effective engagement is more than a checkbox as all parties must value it.

We have been working on 3 things or themes as we are calling it. Collaboration, Consultation and Communication. We are working on how to build Strong connections in our neighborhoods and with families. This is very important to Tammy as our motto is building a stronger community for a better tomorrow.

We have so many different ideas and ways that we are looking at changing how people think it should be. We are all neighbors and what goes on behind closed doors is up to you. However if it can help improve your quality of life it makes a difference. This can be as simple as a home cooked meal delivery or Tammy and Jacqueline bringing a food box which they do. Dropping off a small care package, yes they do it too. These are simple but you feel like you matter because you do. They do a lot for us and never tell anyone but you know it's them.

I know Tammy and Jacqueline have a work session with the City Council but we wanted you to know some of what we are doing and how you can support us as part of this Neighborhood Association. Plus sharing information helps you all have an opportunity to hear from us.

I can share the same information and agree with AJ. I am hoping you are willing to give me a chance. I am scared but you all need to know I have 6 kids and 3 of my children as well as myself have been traumatized by my Ex. One of my boys has a TBI now for trying to protect me. I can't afford to lose work to go to meetings and I am grateful for the opportunity to attend online meetings. I work 2 full-time and 1 part-time job just to provide for my family. And without the support of Tammy and Jacqueline building Greater Northeast Keizer Neighborhood Association I would not have my new job, or my part time job that I am blessed to do from home as I care for my family. I would like you to know that my son was almost hit by a car going to school at Kennedy Elementary; my daughter fell into the road nearly hit by a car as the sidewalk is not there. What is it going to take for sidewalks to go in? Side roads Matter, we matter how the Traffic Safety Committee can say we need more deaths, time we should not have to lose our babies to get a sidewalk.

I listened to the work session, mad and angry we matter, the lady before Tammy S we matter Tammy and Jacqueline have been working on sidewalks for a year. Red tape I know, development of a program, I will help research and put materials together but never come as I have to protect myself and my family. Behind the Scenes OK tell me what to do. Beth T

- Community ownership and leadership in any change effort is essential for its long-term sustainability and success. Fear is one of the biggest barriers that prevent change makers from applying authentic community engagement practices.

The process of working collaboratively with and through groups of people affiliated by geographic proximity, special interest, or similar situations to address issues affecting the wellbeing of those people. This can change from person to person, Tammy asked us what community engagement looks like and what it means to us and this is what it looks like.

The focus of this committee should be how can you engage more, connect more, go to a place where we are at the dog park. I am there each day for an hour in the evening, I have seen Lisa and she is awesome and sweet. Not sure I think Tammy said she is part of Parks. However she talks to folks and we see her care for KRP and I have seen her at others. Seems nice and friendly, I like that.

Community events held throughout our City, Shaney has been seen and interacts with us as does Mrs. Cross and Dan are always super nice and helpful. I have seen Councilor Duran at KRP in preparation for Keizer fest, always pleasant and seem to really enjoy serving. Your parks department, Traffic department should be attending meetings and providing support for this committee and for the Association meetings, they do when an invite is done, what about just coming and being part of us.

I want to say thank you for all the work you ladies do again. I cannot stress enough we need you, your care and it shows through all the little things in your life. We are blessed by you and thanks for taking time to do the newsletters and gathering resources, helping us go through them as we need them and thanks you for helping me personally get connected to the Arches Project and now I am on the list for our own home, this is huge for our family so thanks.

I am writing to you as President of Greater Northeast Keizer Neighborhood Association, during last month's meeting for TRAFFIC SAFETY/BIKEWAYS/PEDESTRIAN COMMITTEE;

Neighborhood Associations voiced opposition to the requirement in the Neighborhood Traffic Management Plan for door-to-door solicitation of signatures. I am concerned this could become a problem for us as Neighborhood Associations to address safety concerns. We had a meeting on this topic alone, with the board and this was a concern as we have a couple who are older in age and respecting the signs on doors is important.

Next is we are looking to add a traffic calming devise in the Greater Northeast Neighborhood Association for Kennedy Elementary school and are looking for this to be placed around may street. As Verda crossing goes in we are looking at the growth and development of the children who will be housed in this community and will also be attending the school. We would like to see a flashing beacon light to allow for safely crossing Verda road to get to the school.

I wonder if we can use some grant funding here to do street art to help with calming the traffic. As West Salem has seen a decrease in the speed on Kingwood near the West Salem Clinic where this art in located in the street. (The Federal grant I mentioned is the Neighborhood Access and Equity grant: https://www.fhwa.dot.gov/inflation-reduction-act/fact_sheets/nae_grant_program.cfm)

Adding sign to slow traffic in our school zones is something we need to address to provide safety pathways for our children going to school.

I have put out a couple of polls with our Next-door and Facebook, as well as an email blast. I have been looking at the online conversations around this topic and have spoken with about 45 people who feel the same way, I ask you to submit a

letter to the Traffic Safety / Bikeway/ Peds committee in support of making this a site for the flashing light that allows our children to cross to and from school safely. I did share that I have spoken with this committee and shared this but we will be drafting a formal letter as well.

Lastly we have a walking group that does different areas in our community; I was presented with a list of items to address. Northview Terrace is in need of a bathroom for our children to use, while we play at this park. They would like one that is handicap accessible as well, not to exclude anyone and provide access for those families that may need the extra support.

- ➤ The entry way entering the Northview Terrace Park has quite a drop off; Children have fallen off bikes and skateboards entering the park.
- Sidewalk repairs near this park need some repairs so allow safe access to Northview Terrace Park.
- On Dearborn we need sidewalk repairs across from the park and heading toward river road.
- ➤ 12th on off Dearborn need to be paved as you enter the lawless end of the road. And we are asking for sidewalks on Lawless both sides of the road.
- ➤ !4th off of Dearborn needs sidewalk repairs in front of 4070, and 4090 area could use to be repaired.
- ➤ Verda needs sidewalks heading to Lockhaven road on both sides to allow safe places for the kids who walk, bus, and people who walk those roads the north side, as the south side is set to be done on right. This leaves the left hand side of the road heading toward the parkway needs to have some sidewalks put in.
- Finally on River road in front of Jiffy Lube, and Jacqueline and I (Tammy) saw an older man in a wheel chair almost fall over due to the sidewalk and driveway and in front of the small plaza on the corner of Dearborn and River . We fear this is not the only one as Tammy rides on the side of the road for this reason.

For place we need support walkways to allow our children to get to school we found this to help until we can get sidewalks in the places we need them. We feel

this may be a good compromise and working with safe route to school may help with this funding as we move forward.

Community Diversity Engagement Committee notes for the work session

Just in case I don't have time to share all my thoughts, I decided to type up my thoughts and share them. Some of these have come from holding conversations with folks and looking for ways to enhance outreach with my community.

Some of my thoughts of what it means to be part of this committee; Community engagement seeks to engage community to achieve sustainable outcomes, equitable decision-making processes, and deepen relationships and trust between government organizations and communities. This should be one of our main focal points, engaging with groups such as Latino businesses; to see what they need how we can help or do they need support. This is just one group, we need to be a group of action we do a lot of talking, but the neighborhood association would like us to attend meetings, and engage talk to those who attend and see what needs they have and how we can add support for growth an better engage.

In demonstrating that community contribution matters, public participation challenges the linear, or one-way relationship between government organizations and communities and promotes productive, durable change through, among other things, such as community events, school meetings, making our communities safer again. We have tagging, theft of items, large group of teens and young adults looking for trouble is what it seems to be, but they may just be gathering.

Having programs and or Committees for community engagement; it results in stronger, more equitable policies. It builds trust between communities and government. And it provides a better understanding and sense of ownership with the community which can lessen push back and make implementation more successful. The importance of community engagement is pretty clear for me it provides a level of interactions within the communities we serve to ensure we are supporting partners and members of the communities we are meeting the needs and if we are not what we are missing so we can create better outcomes. (For example we know how to be a good neighbor this is what we are doing on a larger scale.)

I also believe through feedback, community engagement enables government and public decision-making organizations to listen and, in turn, demonstrate the impact of community contribution. Community engagement, then, builds deeper, stronger and more trusting relationships between public organizations and communities. As I have been working on asking questions and engaging in different ways, this allows me to build better relationships with groups of people, families and those I interact with. This has changed my outlook and made me feel part of something, rather than impacted with cause.

As I have been learning and working within the community I have learned some of why this engagement piece doesn't work. Difficulties in accessing information communities often lack adequate information on policy, plans and budgets, programs and services, all of which is needed for effective public participation. Some of the information is difficult to obtain and understand. I have learned to ask questions but not everyone has that chance. By working through the tough things it can help improve the relevance, quality, and impact of health and well-being measurement, as well as foster trust, empowerment, and social change. However, community engagement also poses some challenges, such

as ethical, practical, that need to be addressed carefully and respectfully. For Keizer we have a good track record but we can always grow more and learn more as I have heard over the last few months.

I attend number of meeting in our community City Council, Parks Advisory Board, Traffic safety/ Bikeways /Pedestrian committee, Keizer Untied, All the SKATS meetings, WKNA meetings and a few others this is one way I engage in our community. I do this and represent Keizer CDEC for SKATS and the Association for the others. We all gifts and the diversity in our back grounds, and need to be attending community meetings, it does not have to be all the time, but at least every month we all take turns and report back with a monthly reports turned in to Dawn at least 10 days before our meeting if possible as she like to include those in our emails with the meeting materials. We were appointed to serve, and my gifts are different from yours, and we all have those things we have passion for, mine is representing those who need an advocate.

I did attend the SEKNA after our meeting on 3/7/24; I was asked if we could provide more support to the Neighborhood Associations, they need us to take action and helps find ways to engage better in the community so we can grow our Neighborhood meetings. Many said we do a lot of talking but action is what is needed. We need to ask how I can support you in whatever meeting you're attending. They will tell us, just like I need to find ways to get more people for in person meetings. Greater Gubser has the same problem how do we get our communities to engage on a regular basis?

Another way we can make a difference is be the voice for those too afraid to speak for themselves. Keizer is 40 and we are developing processes and leading our community and one way we can do this better is being mindful of those who are struggling. Let's look for way not to increase what people have to pay, and rent increase 14% each year people are being priced out of homes. Another way is to create a side walk program that allows us to bring all the sidewalks to code and provide safety for our community. For this we can use an annual report or semi- annual report for every 6 months check in with City Council and the community to see if we need to add more to what we do. Plus, our meetings are open and people can come in to share feedback as they need or want to.

D. Amendments to the SKATS FFY 2024-2029 TIP Steve Dobrinich

Background:

The purpose of this agenda item is to review four amendments to the SKATS FFY 2024-29 Transportation Improvement Program (TIP). See *attachments* for additional information.

- Resolution 24-5: Pedestrian Safety Improvement Crossings (Salem) (Key # 21879): The City of Salem is requesting to add \$500,000 in local overmatch to cover increased cost estimates. Project crossing locations are being updated as well.
- Resolution 24-6: Northwest Oregon 2024-2027 ADA Curb Ramp Design, Phase 2 (Key # 23029): ODOT is requesting to transfer \$2,710,000 from the Preliminary Engineering phase of K23029 (funds reserve) to the Preliminary Engineering phase of K22985.
- Resolution 24-7: <u>Transit Urban (5310)</u> Formula Program 2023 SKT (Key # 21911): SAMTD is requesting to increase the project allocation listed in the TIP by \$153,698 (\$122,958 Federal; \$30,740 local match) to match the actual apportionment.
- Resolution 24-8: Northwest Oregon curve warning upgrades (2027) (Key # 22728): ODOT is requesting to expand the project scope to include locations in the SKATS planning area and add \$821,881 from the All Roads Transportation Safety (ARTS) program to the Preliminary Engineering phase. The project name will be updated to reflect changes.

E. Chair's Suggested Motion (MPO Structure)......Mike Jaffe

Background: At the February SKATS Policy Committee meeting, staff reviewed the agenda materials, including federal regulations about the composition of MPO boards, and "straw-man" options for member representation and votes on the Policy Committee. There was an extended discussion on this topic by the Policy Committee members.

As described in the memo, for this meeting there is a suggested motion from the SKATS Chair, as follows:

"Motion to direct SKATS staff to prepare an amendment to the SKATS Cooperative Agreement to add the City of Aumsville as a voting member of the SKATS Policy Committee. Also, move that the SKATS Bylaws be amended to align with the Cooperative Agreement upon the final completion of the Cooperative Agreement."

The wording in the motion intentionally recognizes that the process to amend the Cooperative Agreement will take an unknown number of months to obtain the necessary signatures. (In 2002/2003, it took 11 months to obtain signatures for the amendment to add Turner to the Policy Committee). Changes to the Bylaws to align with the Cooperative Agreement can be done with a 5-day notice of the proposed change and a majority vote on the amendment.

This order of business (i.e. Cooperative Agreement Amendment first, followed by amending the Bylaws at a later date when the Cooperative Agreement Amendment is finalized) will help to assure that the Cooperative Agreement and the Bylaws do not contradict each other regarding Policy Committee membership and voting.

Transportation Planning Director Mike Jaffe began with a presentation of the memo contents and attachments about MPO Policy Committee representation and amending the SKATS Cooperative Agreement to add the city of Aumsville and/or other changes in membership. Described in the memo are options and examples of various voting structures² used by MPOs in Oregon and outside Oregon, and information on the 2021 change to federal law³ that MPO Boards consider "the equitable and proportional representation of the population of the metropolitan planning area"⁴.

During the presentation Chair Clark clarified that only two documents⁵ require unanimous votes to adopt; otherwise, all other votes are majority rules, as per the SKATS bylaws reliance on Roberts Rules. She stated that in all her time on the committee, she could not recall <u>any</u> vote that was not unanimous. Mr. Jaffe shared the graphic included in the Cooperative Agreement which shows how the Policy Committee can resolve a non-unanimous vote on the MTP or the TIP.⁶

Steve Horning inquired if there are any examples of cities changing their system; starting out with one set of processes in their bylaws and then making a change. Staff did not have any examples, stating that would be difficult to find because it could have been a change to bylaws or a change to cooperative agreements, and most MPOs only have their current set of bylaws available on their websites.

Sadie Carney asked for clarification on whether general-purpose government voting members are required to be elected officials. Mr. Jaffe directed everyone to attachment E of the federal regulations⁷ which state: Transportation Management Area⁸s (TMAs) shall consist of local elected officials, officials of public agencies that administer or operate major modes of transportation in the metropolitan area including providers of public transportation, and appropriate state officials. Federal laws and regulations do not state those precluded; only those required at a minimum.

Commissioner Cameron shared the current 24-29 SKATS TIP project list with a breakdown of the upcoming projects by jurisdiction and costs and asked that they be included as part of the record⁹. This was the TIP table from the SKATS website. In response to the Commissioner's question about exempt and non-exempt air quality projects in the project list, staff provided answers to his questions. There was discussion regarding types of projects, their distribution by jurisdiction, and an explanation of air quality conformity determinations.¹⁰

Salem Mayor Chris Hoy was asked to attend today's meeting to share his views about increasing the representation for the city of Salem of the SKATS Policy Committee. Mayor Hoy expressed that given the addition of Aumsville, now is an opportunity to take a fresh look at the makeup of this group in terms of voting assignments. He said that it's not about changing an outcome. The city wants the residents of Salem to have the voting power that is due given the size of their population. Mayor Hoy encouraged the Policy Committee to come up with a solution reflective of Salem's much larger population in the MPO.

City of Aumsville Mayor Angelica Ceja asked to share her comments and questions. She described her community as a small rural community of 4,200 residents, 27% of whom are marginalized within the community. They have limited resources and do not have access to some public resources like mass transit and a large school system. Many in Aumsville travel to Salem for work and shopping. The mayor feels that the city of Aumsville's voice will be diminished if Salem is provided additional votes and that there is already strong representation for Salem on the board. The mayor stated it is important to work with regional boards like this, where we're talking about equity versus equality.

There was a discussion by Della Seney and Mayor Ceja about the loss of funding opportunities for Aumsville as they will be considered urbanized and part of the MPO, and may have to wait many years to get a project funded by SKATS. Staff clarified that the next TIP's call for projects will be for the 2027 through 2032 time period. Mr. Jaffe also stated that once Aumsville becomes part of the SKATS MPA planning area, then projects in Aumsville that are on the federal classification roadway system are eligible to be funded in the TIP, dependent on other criteria used to select projects, even if the city wasn't a member of the Policy Committee.

Maria Hinojos Pressey thanked both mayors for their insight. She said that the ask for a facilitated process by the Cherriots Board was to take all the individual thoughts and concerns expressed around the table and reach an agreement that would benefit all of us. She believes the voting structure could use some updating, supports adding Aumsville and, along with a second vote for the city of Salem, is interested in more information regarding rotating representation on the committee. She mentioned that it may be unfair to ask one Salem city councilor to represent such a large demographic area.

Mayor Hoy said Salem doesn't object to adding Aumsville to the committee and agrees that we're better off when we work together. His perspective is that -- just like Mayor Ceja doesn't want the voices of Aumsville to be diminished -- he doesn't want his residents' voices to be diminished and if Aumsville is added without changing the structure Salem will continue to have the same single vote as everybody despite representing 175,000 people. He wants a fair and balanced representation and process.

City of Turner Mayor Steve Horning stated he appreciated everyone's comments and as a group he believes the committee has always been fair and impartial. He said that looking at the money that's been allocated over the years, it feels that Salem's received their proportional share. He agrees that the city of Salem could have more voices at the table (to better represent the population of Salem) by adding three or four seats for the different parts of town but keeping one vote for Salem.

Commissioner Cameron stated that he represents 98.6% of the population being discussed. He has historically worked with all the cities within the MPO and in Marion County to get projects done. He hesitates to change something that has been working and he thinks the MPO should continue with its current structure. He further made the point that SAMTD represents the entire UGB because their routes go to every jurisdiction and the Salem Keizer School District represents the majority of the MPO population; should Cascade School District be added to the MPO, and the school districts have a rotating vote? The Commissioner acknowledged Councilor Phillips's concerns while also stating that he has been a good member, and the structure has been working thus making it hard for him to see a reason to change that.

Director Carney stated we have broad agreement that the existing structure has worked for people in the room, but there are a lot of people who aren't in this room, and believes there should be a more equitable representation in this body. She stated the desire for an inclusive facilitated process that invites the community to participate and voice their opinions.

Mayor Ceja expressed that the people on this committee – whether paid or unpaid -- are elected officials that represent their communities, and through their elected official their resident's voices are represented at this committee.

Director Carney responded that she agreed with the view that smaller jurisdictions have intimate relationships about their local issues and with the residents in that community. In contrast, Councilor Phillips is challenged to have that same opportunity to represent 175,535 people, and the huge number of roads and intersections in the city of Salem. She's not saying that rural voice matters less but that Salem residents' voices matter as much as the rural residents. Mayor Ceja views the city of Salem as having four invested voices — the school district, Cherriots, and the city of Salem, and the county - all represented on the MPO committee.

Councilor Phillips noted that the city of Salem has never been opposed to adding Aumsville but asks why the members are opposed to one additional vote for Salem. He pointed out that the city of Salem is equal to 42 'Aumsvilles', 3.4 'unincorporated Marion Countys' or 4.6 'Keizers,' so why can't Salem have one more vote. He noted the new federal emphasis on proportionality. He feels the voting structure should be proportionally based, supports a facilitated process, and is willing to accept the results of that process. He doesn't agree with the view that Cherriots and the school district always side with Salem since neither of them are general purpose governments. He wanted to have some discussions of the options on the straw man list and described his initial thoughts of each one.

Mayor Horning asked if Salem had two votes on the Policy Committee during the last 20 years, what would have been different? Councilor Phillips didn't have a specific "one project" that would have been different, although conversations at the meetings would have been different.

Director Carney stated she was inspired by the information that the staff compiled regarding a more inclusive representation; she feels that the committee would benefit from a greater diversity of voices, whether that be voting or non-voting.

Commissioner Lyle Mordhorst spoke about his representation on the committee; he said he represents roughly 3800 people within the Salem urban growth boundary¹¹ but was elected to represent 92,000 in Polk County. He views Salem as the hub that keeps the whole Willamette Valley moving. He discussed the challenges of travel in the rural areas and the travel that comes from the rural areas into or through the city of Salem. He pointed to the information on SKATS TIP projects¹² that shows the dispersion of monies over the last 25 years; the large proportion of those funds went to the city of Salem or SAMTD. He also commented that the school district is not a required voting member and could be a non-voting member of the SKATS Policy Committee to hear their input. SKATS could give the School District's vote to Aumsville to keep the total number of votes at eight. He said that would not "water down" the vote. He asked the committee if that should be considered.

Mayor Hoy left the meeting at approximately 1:45 pm.

Director Hinojos Pressey said a facilitated process could put all the options like Commissioner Mordhorst's on the table, where a governmental entity like the Salem-Keizer School District could be rotated, or participating in a non-voting capacity, or other options. She commended staff on the history, information, and background provided to the Policy Committee. A facilitated process could put everything on the table and could help potentially come to a very solid agreement.

Chair Clark shared that the city of Keizer's point of view is to get the city of Aumsville on the committee ASAP; that is the number one priority. She doesn't want any harm to come to Aumsville. She agreed that the data on the distribution of funded projects showed most of the allocation of resources has been comprehensive and done with an eye toward full urban upgrades and providing for all modes of travel. She expressed that she represents Keizer's transportation system plan, which represents her entire community. Keizer's priority is to bring Aumsville in as a voting member posthaste.

Councilor Phillips stated that he is prepared to support a motion to officially bring Aumsville on in an ex officio status to be able to make motions and apply for projects. But he's not in a position to bring them onto as a full voting member without the city of Salem's general-purpose government getting an additional vote. He wanted to hear more from staff to assure that Aumsville will be able to apply for projects without delay.

Mr. Jaffe referred to the letter from Ron Harding (Aumsville's City Administrator) and the letter's statement that being part of the urbanized area would make Aumsville ineligible for rural grants. Mr. Jaffe also said that once Aumsville is part of the metropolitan planning area, the city would be eligible to apply for federal funding provided by SKATS through its TIP project selection process.

Commissioner Cameron suggested that we table the discussion so that members and staff could find answers to the funding questions discussed today.

Director Hinojos Pressey left the meeting at 2:00 pm.

Staff reminded the committee that some initial outreach to potential facilitators was done last summer, and if the committee chose to go with a facilitated process, they should discuss how the board would be involved in selecting a facilitator. Chair Clark said her concern is about a process that delays Aumsville's addition to the SKATS Policy Committee.

Mayor Horning made a motion to amend the Cooperative Agreement and SKATS Bylaws to add Aumsville as a voting member identically to what happened to Turner in 2003. It was seconded by Commissioner Mordhorst.

In the discussion that followed, Mayor Horning stated he made the motion as he does not feel there has been previous harm done to the jurisdictions with the current voting structure.

Mr. Jaffe brought up the concern about proper procedures since what was published in the agenda was a discussion of the materials and options [in Attachment A] and not requesting the committee to take an action at this time. He also noted that School Board member Hinojos Pressey needed to leave the meeting before the motion was made. Mayor Clark agreed that

this motion was not published on the agenda and would want to check the SKATS bylaws. ¹³ She appreciates the spirit of the motion but agreed with Mr. Jaffe about it not being noticed on the agenda.

Mayor Horning withdrew his motion based on the input from staff, until the next meeting. He said he would like to hear at next month's meeting how any member was harmed by the current process before he would support more votes for a member.

Director Carney stated that not having voices at the table representative of communities subject to decades of disinvestment is an example of harm. She added that transportation planning, and the government as a whole, are not doing a good job of equitably representing the communities that are impacted. The committee had further discussion about whether the facilitated process that has been discussed includes involving community members in that process or if it is a facilitated discussion solely of the members of the Policy Committee. Mr. Jaffe said how a facilitated process is conducted is the Policy Committee's decision, or it could be assigned to a subcommittee as allowed in the Bylaws. He said that this is the committee's process to define. He said that he wouldn't recommend the Policy Committee rush to judgment and that the process for making decisions be clearly communicated before meetings.

Chair Clark summarized that there were two decision points that remain: 1. The straw man options in the memo have been given thought by the members; 2. Doing a facilitated process or not. In her opinion, if the Policy Committee did go through a facilitated process, it should be clearly defined, along with the timeline.

Mr. Jaffe suggested the committee could postpone the two items that we didn't get to ¹⁵ which were informational. Mr. Jaffe suggested also that he meet with the chair and vice-chair before the March Policy Committee meeting to discuss what would be on the agenda.

Chair Cathy Clark adjourned the meeting at 2:19 p.m.

Re: Process for Amending the SKATS Cooperative Agreement and Bylaws

Introduction

This is a continuation of the topic discussed in February. Chair Clark is submitting a suggested motion for SKATS' Policy Committee's consideration. The purpose of the motion is to have staff draft an amendment to the SKATS Cooperative Agreement, adding Aumsville as a voting member. The second part of the motion is to change the SKATS Bylaws once the Cooperative Agreement is finalized. The chair's suggested motion is:

"Motion to direct SKATS staff to prepare an amendment to the SKATS Cooperative Agreement to add the City of Aumsville as a voting member of the SKATS Policy Committee. Also, move that the SKATS Bylaws be amended to align with the Cooperative Agreement upon the final completion of the Cooperative Agreement."

Background

The February SKATS Policy Committee meeting packet included a staff memo plus several attachments. The memo, attachments, and staff presentation discussed the existing SKATS Cooperative Agreement and Bylaws, current federal regulations about MPO Board composition, the 2021 update to federal law on MPO board composition, a scheduled notice of proposed rulemaking (NPRM) that may have more information on the change to the federal law, minutes from the August 2023 PC meeting minutes on MPO composition, and multiple examples of voting membership of other MPOs in Oregon and in other states. Attachment A of the packet included five options for adding Policy Committee members to represent the city of Aumsville and/or the city of Salem. Staff weren't able to fully present these "strawman" options at the January meeting and there was limited discussion of them at the meeting.

Toward the end of the meeting, there was a motion proposed by Mayor Horning to change the Cooperative Agreement and the SKATS Policy Committee bylaws to add the city of Aumsville, with no other changes. After committee discussion and comments by staff, the chair agreed that the motion was improper because a vote to change either the bylaws or the Cooperative Agreement was not noticed in the agenda materials. (The Action Requested for the February agenda item was "Discussion of the materials and the options presented in Attachment A.") It should have been noted at the time that Article V of the Bylaws prescribes the process for amending the Bylaws (see below). Lastly, amending the Cooperative Agreement is a different and longer process than amending the Bylaws, as described in this memo.

Amendments(s) to the SKATS Policy Committee Bylaws

The accepted process for amending the SKATS bylaws is specified in Article V of the bylaws themselves, as shown in the box below.

[From SKATS Bylaws, adopted11/25/03]

Article V

Amendments To The Bylaws

The Bylaws may be amended at any regular meeting of the SKATS Policy Committee, provided that written notice of, and the proposed amendment is mailed to each member of the committee not less than five days prior to such meeting.

Amendments to the SKATS Cooperative Agreement

Amending the SKATS Cooperative Agreement is a very different process from amending the Bylaws. The Cooperative Agreement (or an Amendment to it) is <u>not</u> adopted by a unanimous or majority vote at a Policy Committee meeting. An Amendment to the existing Cooperative Agreements (or a revised Cooperative Amendment) <u>requires the signatures of the appropriate Parties of the agreement</u>. The Policy Committee can spend time at their meeting to discuss and develop the text of the proposed amendment and make a motion to forward the amendment to the appropriate Parties. Once the text of the amendment is approved, the Amendment is sent to the parties for their review and requested signature.

For comparison, in 2002 there were several months of discussion in preparation of Amendment #1 to the Cooperative Agreement, whose purpose was to add the city of Turner to the SKATS Policy Committee. After drafting an amendment and circulating it to the local jurisdictions in November 2002, it took about 11 months to gather all the necessary signatures. See *attached* Timeline for details.

Staff Recommendations

- 1. Proceed with the Chair's suggested motion (see memo's Introduction Section)
- 2. Because of the unknown amount of time it may take to finalize an amendment, <u>staff</u> <u>highly recommended that changes to the Bylaws wait until the Cooperative Agreement</u> <u>has completed its process.</u> By waiting, we can finalize both the Cooperative Agreement and the Bylaws within a month of each other, <u>so that the two documents do not contradict</u> each other regarding the membership and voting structure of the Policy Committee.
- 3. Direct staff and subcommittee to work on other recommended changes to the SKATS Bylaws, with a formal recommendation to the Policy Committee at a future date.

Timeline of Amending the SKATS Cooperative Agreement to Add Turner in 2002-2003

20240312. Revised 20240313, 20240318

Timeline based on meeting packets and memos of PC and TAC meetings in 2002 and 2003

- May 1, 2002, the US Census Bureau published in the Federal Register that the Salem Urbanized Area now included the city of Turner.
- At the May 2002 Policy Committee meeting, staff introduced the TMA concept and the need for 'incorporating Turner into the SKATS process and products.'
 - A letter was sent (dated May 21, 2002) to the city of Turner introducing SKATS and asking for participation.
- At the June 17, 2002, PC meeting it was mentioned that the city of Turner responded with the representatives to the PC. It was noted that the PC '...will need to review the issues related to the roles of the city of Turner in the regional planning process.'
- At the November 12, 2002, TAC meeting, a draft amendment to the Cooperative Agreement was presented and discussed. Items discussed include:
 - Whether to include language on the level of financial support that the city of Turner should provide. The TAC decided to defer the financial support discussion to a future meeting.
 - o The recommendation was to add Turner to Section C of the Cooperative Agreement but not to make changes in Section E (on the RTSP and TIP adoption process).
 - It was mentioned that if the local jurisdictions adopt the amendment, the PC will review and amend the PC bylaws and the TAC bylaws.
 - Motion to forward the draft to the PC passed unanimously.
- At the November 26, 2002, PC meeting a draft amendment to the Cooperative Agreement was presented and discussed.
 - The draft amendment was discussed and then a motion was made to release the draft Cooperative Agreement to the local jurisdictions for approval. Unanimous approval.
- In the February 18, 2003, PC packet (but deferred and presented at the March 25, 2003, meeting) there was discussion about whether to add the Salem-Keizer School District as a signatory to Amendment #1. (Note: The School District was deliberately omitted as a signatory for the original 1987 Cooperative Agreement.) After discussion, a motion was made to retain the draft Cooperative Agreement Amendment #1 as is [i.e., not include the School District as a signatory to Amendment #1 but retain them as a member of the Policy Committee]. Motion passed unanimously.
- May 2003 to August 2003: Signatures of the SKATS members to Amendment #1 obtained

- September/October 2003: Signatures of Oregon Assistant Attorney General (9/30/2003) and ODOT Deputy Director (10/6/03) obtained
- November 25, 2003: amending the Bylaws to add Turner was discussed and completed.

In summary, it took seven months (May to November 2002) of discussion by the Policy Committee to prepare draft Amendment #1 to the Cooperative Amendment, with additional discussion in March 2003. Amendment #1 was circulated to the local governments for signatures, with signatures obtained from May to August of 2003. The MWVCOG Executive Director signed in early September 2003. Signatures from ODOT were obtained in late September and early October of 2003. It took 11 months from the release of Amendment #1 (in November 2002) to the fully signed completed Amendment #1 (in October 2003).

Options for adding Aumsville and adding representation for Salem to the SKATS Policy Committee For Discussion Purposes

February 20, 2024

1. Add Aumsville; no other changes

- a. City of Aumsville is added to the SKATS PC.
- b. Every member gets one vote.
- c. Total regular voting members = 9

2. Add Aumsville; add second voting member for Salem

- a. City of Aumsville is added to the SKATS PC.
- b. A second Salem member is added to the PC, and both are voting members.
- c. Total regular voting members = 10

3. Add Aumsville; add <u>non-voting</u> member for Salem; Salem can call for a second voting member (if that motion receives 50% or more support).

- a. City of Aumsville is added to the SKATS PC.
- b. A second Salem member is added to the PC, but the second Salem member is non-voting.
- c. Total regular-voting members = 9. 1 non-voting member for Salem.
- d. Before any vote on an action by the Policy Committee, Salem can make a motion that both Salem members get to vote on that action item. The motion for both Salem members voting on the action item must be passed by 50% or more of the regular-voting members in attendance at the meeting; if the motion passes, the action item is tabled to the next meeting when Salem can have two votes on that action.

4. Add Aumsville; add <u>non-voting</u> member for Salem; review the Cooperative Agreement in the future to add second voting member for Salem.

- a. City of Aumsville is added to the SKATS PC.
- b. A second Salem member is added to the PC, but the second Salem member is non-voting
- c. Total regular voting members = 9. 1 non-voting member for Salem.

d. Two options in the future:

- The Cooperative Agreement will be reviewed in 5 years (i.e. 2019) to re-visit adding a second regular-voting member for Salem; or
- ii. If after the 2030 Census one or more additional jurisdictions are added to the Salem urban area, the Cooperative Agreement will be updated to also add at least one more City of Salem regular-voting member on the Policy Committee.

- 5. Add Aumsville; create a tiered-voting option when two jurisdictions support this.
 - a. City of Aumsville is added to the SKATS PC.
 - b. Salem representation could be any of the options #2, #3, or #4 above.
 - c. Regular-voting is the default method used for action items. A tiered-voting option is created. Tiered-voting for an action item can be requested (either <u>before</u> any action item vote or <u>immediately after</u> a regular vote on an action item) and must be supported by any two voting members from different representative entities. If that occurs, the item is tabled to the next meeting of the Policy Committee when tiered-voting will be used for that specific action item.
 - d. Draft table of regular-voting and four different options for tiered-votes (shown as a starting point for further discussion)

COOPERATIVE AGREEMENT

DUTIES AND RESPONSIBILITIES FOR COOPERATIVELY CARRYING OUT TRANSPORTATION PLANNING AND PROGRAMMING

THIS AGREEMENT made and entered into this the day of the land of t

WITNESSETH

WHEREAS, the Highway Act of 1973 set forth requirements for Transportation Planning and provided funds for this purpose to Metropolitan Areas of 50,000 population or more to carry out a continuous, comprehensive and cooperative (3C) transportation planning process; and

WHEREAS, STATE, COG, SALEM, KEIZER, MARION, POLK and TRANSIT DISTRICT participate in the "3C" process in the Salem/Keizer Metropolitan Area; and

WHEREAS, the PARTIES desire to update, clarify, and streamline the process;

NOW, THEREFORE, the PARTIES hereto do mutually agree as follows:

AGREEMENT - Page 1 of 5

Section A. The COG will provide administrative services and, along with STATE, carry out the technical responsibilities for the transportation planning process.

Section B. The Council of Governments shall retain the sole responsibility for acceptance of all contracts, grants and gifts for transportation planning in the Salem area, and all fiscal and financial responsibility therefore. The Director of the COG shall select and supervise the transportation planning coordinator and staff assigned to the transportation planning process.

Section C. The Salem Area Transportation Study (SATS) Coordinating Committee will be renamed the Salem/Keizer Area Transportation Study (SKATS) Policy Committee. Voting membership on the SKATS Policy Committee shall consist of:

- 1. One member, Marion County Board of Commissioners
- 2. One member, Polk County Board of Commissioners
- 3. One member, City of Salem City Council
- 4. One member, City of Keizer City Council
- 5. One member, Salem Area Mass Transit District Board of Directors
- 6. One member, Oregon Department of Transportation
- 7. One member, School District 24J Board

Section D. The SKATS Policy Committee is responsible for developing Bylaws, operating procedures, transportation plans, transportation improvement programs, and work programs, and to take other actions necessary to carry out the transportation planning process.

Section E. The SKATS Policy Committee shall use the following process in adopting the Transportation Plan and Transportation Improvement Program:

- If the Policy Committee approves the document with a unanimous vote of the Policy Committee members attending a meeting as described in Section F., then the document is adopted.
- If the Policy Committee approves the document with less than a unanimous vote (as described in Section F.) then the document shall be referred to the governing bodies of Marion, Polk, Salem, Keizer, and the District for endorsement. All five jurisdictions must endorse the document for it to be considered adopted. If all five jurisdictions do not endorse the document, they shall individually or through the Policy Committee develop a mutually acceptable proposal which will then be adopted in accordance with paragraphs 1 and 2 of this Section.

A graphic representation of this adoption process is presented in Attachment A.

Section F. The unanimous vote of the Policy Committee members required in Section E. shall meet the following requirements:

- All of the members in attendance must vote in favor of the action.
- 2) All of the members must have been notified of the meeting time, date, and place.

3) All of the members must have been notified that the issue was on the meeting agenda prior to the meeting.

Section G. The SKATS Policy Committee has the authority to take final action on all other matters pertaining to the transportation planning process.

Section H. Transportation Planning documents such as the Transportation Plan and the Transportation Improvement Program which have been prepared, adopted, and are currently in effect, will remain in effect until the SKATS Policy Committee adopts new, updated, or revised versions of the documents.


Section I. The SKATS Policy Committee shall review this agreement on or before January, 1992 and every five years thereafter and recommend revisions as desired to the PARTIES. This agreement will remain in effect until revised or replaced by the PARTIES.

Section J. This Agreement supersedes all previous agreements among the respective parties covering the same subject, particularly the Agreement of October 30, 1980 among the State, COG, Salem, Marion, Polk and District; and the October 14, 1980 Joint Resolution between COG and the SATS Coordinating Committee.

AMENDMENT NO. 1 to the COOPERATIVE AGREEMENT

DUTIES AND RESPONSIBILITIES FOR COOPERATIVELY CARRYING OUT TRANSPORTATION PLANNING AND PROGRAMMING

THE STATE OF OREGON, by and through its Department of Transportation, THE MID-WILLAMETTE VALLEY COUNCIL OF GOVERNMENTS, THE CITY OF SALEM, THE CITY OF KEIZER, MARION COUNTY, POLK COUNTY, and THE SALEM AREA MASS TRANSIT DISTRICT (referred to collectively as "PARTIES") entered into a cooperative agreement for duties and responsibilities for cooperatively carrying out transportation planning and programming. This Agreement was approved by the Oregon Transportation Commission on March 20, 1987, at which time the Director, Oregon Department of Transportation, was authorized and directed to sign the Agreement for and on behalf of the Commission.

It has now been determined by the "PARTIES" that the agreement referenced above, while remaining in full force and effect, shall be amended by this Amendment No. 1 to add THE CITY OF TURNER as a voting member on the Salem-Keizer Area Transportation Study (SKATS) Policy Committee.

Therefore, the Cooperative Agreement shall be amended as follows:

Section C of the Cooperative Agreement shall be amended to add subsection 8 to read as follows:

Section C. The Salem Area Transportation Study (SATS) Coordinating Committee will be renamed the Salem/Keizer Area Transportation Study (SKATS) Policy Committee. Voting membership on the SKATS Policy Committee shall consist of:

- 1. One member, Marion County Board of Commissioners
- 2. One member, Polk County Board of Commissioners
- 3. One member, City of Salem City Council
- 4. One member, City of Keizer City Council
- 5. One member, Salem Area Mass Transit, District Board of Directors

- 6. One member, Oregon Department of Transportation
- 7. One member, School District 24J Board
- 8. One member, City of Turner City Council

This agreement shall be effective on the date all required signatures are obtained.

IN WITNESS WHEREOF the parties hereto have caused this Agreement to be signed in their respective names by their duly authorized representatives as of the dates set forth below.

The Oregon Transportation Commission on January 16, 2002, approved Delegation Order No. 2, which authorizes the Director to approve and execute agreements for day-to-day operations when the work is related to a project included in the Statewide Transportation Improvement Program or a line item in the biennial budget approved by the Commission.

Salem-Keizer Area Transportation Study Policy Committee

BYLAWS

Article I

Name

This Committee, established by an Intergovernmental Cooperative Agreement entered into on April 6, 1987, shall be called the SKATS Policy Committee and is the designated Metropolitan Planning Organization (MPO) for the Salem-Keizer Urban Area. This agreement was amended October 6, 2003.

Article II

Purpose

The SKATS Policy Committee is the policy committee of the Salem-Keizer Area Transportation Study. The purpose of the Policy Committee is to identify transportation policies, issues, and needs which are areawide in scope; and to plan and recommend actions in areas of intergovernmental concern. It is the SKATS Policy Committee's responsibility to insure that transportation decisions are consistent with areawide goals and objectives.

The Policy Committee will be supported by advisory committees as the Policy Committee deems appropriate.

The responsibilities of the SKATS Policy Committee are to:

- 1. Provide policy direction in the development of the areawide transportation plans and work programs.
- 2. Recommend transportation plans, policies, programs, and priorities to the participating units of government for their adoption as appropriate.
- 3. Help member agencies coordinate their respective implementation programs.
- 4. Serve as the forum for joint, cooperative discussion and decision-making.
- 5. Prepare, update, and adopt the Regional Transportation Systems Plan (RTSP).
- 6. Annually prepare and adopt a Unified Planning Work Program (UPWP).
- 7. Prepare and adopt the Transportation Improvement Program (TIP).

SKATS Policy Committee Bylaws Page 1 of 3

- 8. Prepare other administrative documents that may be required to carry out the transportation planning process.
- 9. Adoption of documents will be in accordance with the processes outlined in the April 6, 1987 Cooperative Agreement, *as amended*.

Article III

Organization

- A. The SKATS Policy Committee shall consist of eight members appointed by their governmental unit as identified in the Cooperative Agreement. These are:
 - 1. One member, Marion County Board of Commissioners
 - 2. One member, Polk County Board of Commissioners
 - 3. One member, City of Salem City Council
 - 4. One member, City of Keizer City Council
 - 5. One member, School District 24J Board
 - 6. One member, Salem Area Mass Transit District Board of Directors
 - 7. One member, Oregon Department of Transportation
 - 8. One member, City of Turner City Council
- B. A quorum shall consist of not less than four (4) voting members.
- C. There shall be held annually at the first meeting of the calendar year, election of officers, consisting of Chairperson and Vice-Chairperson.
- D. The Chairperson of the SKATS Policy Committee shall conduct all meetings of the Policy Committee and appoint subcommittees as required and specify assignments and deadlines of subcommittee reports.
- E. The Vice-Chairperson of the SKATS Policy Committee shall conduct meetings of the Policy Committee in the absence of the Chairperson. In the absence of the both the Chairperson and the Vice Chairperson, the Chair will delegate another member of the committee to conduct that particular meeting prior to the meeting date.
- F. The Chairpersons of all SKATS Advisory Committees and a representative of the Marion, Polk, Salem, *Turner*, and Keizer Planning Commissions are encouraged to participate (in a non-voting capacity) in Policy Committee meetings.
- G. The jurisdiction of a regular voting member, who is unable to attend a Committee

meeting is encouraged to send another representative who meets the criteria in Article IIIA.

Article IV

Meetings

Regular meetings shall be held monthly. The local newspaper must receive notification of meetings at least 24 hours prior to any meeting.

Written minutes will be taken at each meeting. Parliamentary Procedure as defined in Robert's Rules of Order Newly Revised will be followed and the Oregon Open Meetings Law (ORS 192.610 to 192.690) requirements will be adhered to at all times. The Chairperson shall enter into discussions and vote, the same as any other voting member.

In an emergency, telephone polls/votes may be conducted in lieu of a meeting with approval of the Chairperson. Votes will be formalized at the next meeting.

Article V

Amendments To The Bylaws

The Bylaws may be amended at any regular meeting of the SKATS Policy Committee, provided that written notice of, and the proposed amendment is mailed to each member of the committee not less than five days prior to such meeting.

As a result of the Technical Advisory Committee's discussion of the Cooperative Agreement and recommendation that the SKATS Policy Committee consider adding the Salem-Keizer School District 24J as a signatory, I reviewed the minutes from the meetings held in 1986 surrounding the development of the Cooperative Agreement. The following is a brief overview of the considerations and decisions related to the composition of the current Agreement.

- The structure, membership, and operation of the Metropolitan Planning Organization (MPO) is the decision of the units of general-purpose local government (i.e., cities and counties) and must be approved by the Governor.
- The MPO should also include those agencies responsible for key portions of the transportation system (ODOT and the Salem Area Transit). It may also include other local entities that are considered valuable to the transportation planning process by the key members.
- When the current Cooperative Agreement was developed in 1986-87, it was developed by local elected officials not staff. One of the recurring themes of discussion was the importance of self-control of the MPO's own destiny and the ability to make decisions that were not "second-guessed" or overruled by others. Following that train of thought, there was a deliberate effort to limit the actual "parties" to the Cooperative Agreement to only those jurisdictions with direct control of the public transportation infrastructure.
- As a consequence, the elected officials at the time made a specific distinction between those agencies that were required to decide on the formation of the MPO and those that would be invited to participate in the SKATS process.

 Thus, the omission of the Salem-Keizer School District 24J as a signatory in 1987 was deliberate and not an oversight and was considered a proactive policy decision.

This information is provided so that the current members of the SKATS Policy Committee are aware of some of the rationale utilized by your predecessors in developing the existing agreement.



The original letter was in response to the letters from Salem residents. We were simply countering their claims, not representing Aumsville as a funding authority.

It seems like SKATS staff would have a much better understanding of how the MPO works and what funding qualifies than I, as Aumsville is new to this process. However, I will do my best to answer the committee's request. My understanding is that Aumsville is now listed as part of the MPO and thus all application criteria are as an MPO entity for the federal transportation grant programs.

When I search Rural grant opportunities and go through the eligibility process. We are no longer listed as a rural eligible community, see the Eligibility classification below. I have included a couple of grant locations for reference, we are showing these for reference to our understanding. We do not know what future grant opportunities would present themselves and which of those we would even want to apply for. We are just highlighting that the federal view of the city is no longer rural.

Hi Mike,

I am not sure if this is helpful as I know you were looking for something more definitive, but please let me know if you have any follow-up questions.

"The updated provision in 23 U.S.C. 134(d)(3)(D) is on the books and in effect now. This provision will also be included in the Notice of Proposed Rulemaking (NPRM) for the upcoming update to 23 CFR Part 450. Through that NPRM, FHWA and FTA will invite the public to comment on this provision and other updates to the planning regulations. At this point in the rulemaking process, I'm not in a position to get ahead of the NPRM, but I can share with you this publicly available report that the House Committee on Transportation and Infrastructure put together to accompany the Infrastructure Investment and Jobs Act (IIJA). Here is a snippet:

(D) Equitable and proportional representation.--

(i) In general. -- In designating officials or representatives under paragraph (2), the metropolitan planning organization shall ensure the equitable and proportional representation of the population of the metropolitan planning area.

(ii) Savings clause. -- Nothing in this paragraph shall require a metropolitan planning organization in existence on the date of enactment of this subparagraph to be restructured.

(iii) Redesignation. -- Notwithstanding clause (ii), the requirements of this paragraph shall apply to any metropolitan planning organization redesignated under paragraph (6).

I will also say that in the conversations I've had with FHWA Division Offices, FTA Regional Offices, State DOTs, MPOs, and transit agencies during TMA Certification Reviews, I've heard a lot of discussion about geographic representation, proportional membership, proportional voting, and other voting structures and decisionmaking procedures. Please encourage your planning partners to comment on the NPRM when it is published (hopefully soon, fingers crossed)."

Until the regulations are updated (23 CFR 450 and 420), I am expecting there will be more discussions on the interpretation of equitable and proportional representation. Potentially guidance etc.......

§ 450.310 Metropolitan planning organization designation and redesignation.

- (a) To carry out the metropolitan transportation planning process under this subpart, an MPO shall be designated for each urbanized area with a population of more than 50,000 individuals (as determined by the Bureau of the Census).
- (b) MPO designation shall be made by agreement between the Governor and units of general purpose local government that together represent at least 75 percent of the affected population (including the largest incorporated city, based on population, as named by the Bureau of the Census) or in accordance with procedures established by applicable State or local law.
- (c) The FHWA and the FTA shall identify as a TMA each urbanized area with a population of over 200,000 individuals, as defined by the Bureau of the Census. The FHWA and the FTA shall also designate any urbanized area as a TMA on the request of the Governor and the MPO designated for that area.

(d) TMA structure:

- (1) Not later than October 1, 2014, each metropolitan planning organization that serves a designated TMA shall consist of:
 - (i) Local elected officials;
 - (ii) Officials of public agencies that administer or operate major modes of transportation in the metropolitan area, including representation by providers of public transportation; and
 - (iii) Appropriate State officials.
- (2) An MPO may be restructured to meet the requirements of this paragraph (d) without undertaking a redesignation.
- (3) Representation.
 - (i) Designation or selection of officials or representatives under paragraph (d)(1) of this section shall be determined by the MPO according to the bylaws or enabling statute of the organization.
 - (ii) Subject to the bylaws or enabling statute of the MPO, a representative of a provider of public transportation may also serve as a representative of a local municipality.
 - (iii) An official described in paragraph (d)(1)(ii) shall have responsibilities, actions, duties, voting rights, and any other authority commensurate with other officials described in paragraph (d)(1) of this section.

- (4) Nothing in this section shall be construed to interfere with the authority, under any State law in effect on December 18, 1991, of a public agency with multimodal transportation responsibilities—
 - (i) To develop the plans and TIPs for adoption by an MPO; and
 - (ii) To develop long-range capital plans, coordinate transit services and projects, and carry out other activities pursuant to State law.
- (e) To the extent possible, only one MPO shall be designated for each urbanized area or group of contiguous urbanized areas. More than one MPO may be designated to serve an urbanized area only if the Governor(s) and the existing MPO, if applicable, determine that the size and complexity of the urbanized area-make designation of more than one MPO appropriate. In those cases where two or more MPOs serve the same urbanized area, the MPOs shall establish official, written agreements that clearly identify areas of coordination, and the division of transportation planning responsibilities among the MPOs.
- (f) Nothing in this subpart shall be deemed to prohibit an MPO from using the staff resources of other agencies, non-profit organizations, or contractors to carry out selected elements of the metropolitan transportation planning process.
- (g) An MPO designation shall remain in effect until an official redesignation has been made in accordance with this section.
- (h) An existing MPO may be redesignated only by agreement between the Governor and units of general purpose local government that together represent at least 75 percent of the existing metropolitan planning area population (including the largest incorporated city, based on population, as named by the Bureau of the Census).
- (i) For the purposes of redesignation, units of general purpose local government may be defined as elected officials from each unit of general purpose local government located within the metropolitan planning area served by the existing MPO.
- (j) Redesignation of an MPO (in accordance with the provisions of this section) is required whenever the existing MPO proposes to make:
 - (1) A substantial change in the proportion of voting members on the existing MPO representing the largest incorporated city, other units of general purpose local government served by the MPO, and the State(s); or
 - (2) A substantial change in the decisionmaking authority or responsibility of the MPO, or in decisionmaking procedures established under MPO by-laws.
- (k) Redesignation of an MPO serving a multistate metropolitan planning area requires agreement between the Governors of each State served by the existing MPO and units of general purpose local government that together represent at least 75 percent of the existing metropolitan planning area population (including the largest incorporated city, based on population, as named by the Bureau of the Census).
- (I) The following changes to an MPO do not require a redesignation (as long as they do not trigger a substantial change as described in paragraph (j) of this section):
 - (1) The identification of a new urbanized area (as determined by the Bureau of the Census) within an existing metropolitan planning area;
 - (2) Adding members to the MPO that represent new units of general purpose local government resulting from expansion of the metropolitan planning area;

- (3) Adding members to satisfy the specific membership requirements described in paragraph (d) of this section for an MPO that serves a TMA; or
- (4) Periodic rotation of members representing units of general-purpose local government, as established under MPO by-laws.
- (m) Each Governor with responsibility for a portion of a multistate metropolitan area and the appropriate MPOs shall, to the extent practicable, provide coordinated transportation planning for the entire MPA. The consent of Congress is granted to any two or more States to:
 - (1) Enter into agreements or compacts, not in conflict with any law of the United States, for cooperative efforts and mutual assistance in support of activities authorized under 23 U.S.C. 134 and 49 U.S.C. 5303 as the activities pertain to interstate areas and localities within the States; and
 - (2) Establish such agencies, joint or otherwise, as the States may determine desirable for making the agreements and compacts effective.

23 U.S. Code § 134 - Metropolitan transportation planning

- (3) Representation.—
- (A) In general.—

Designation or selection of officials or representatives under paragraph (2) shall be determined by the metropolitan planning organization according to the bylaws or enabling statute of the organization.

- (B) Public transportation representative.—
- Subject to the bylaws or enabling statute of the metropolitan planning organization, a representative of a provider of public transportation may also serve as a representative of a local municipality.
- (C) Powers of certain officials.—

An official described in paragraph (2)(B) shall have responsibilities, actions, duties, voting rights, and any other authority commensurate with other officials described in paragraph (2).

(D) Considerations.—

In designating officials or representatives under paragraph (2) for the first time, subject to the bylaws or enabling statute of the metropolitan planning organization, the metropolitan planning organization shall consider the equitable and proportional representation of the population of the metropolitan planning area.
