Appendix "A" City Council Committee

Name: Community Diversity Engagement Committee

Purpose: To act in an advisory capacity to the Keizer City Council and to advise on action for community engagement by:

- 1. Listening to understand. Keizer wants to let everyone know we are all included when we talk about the Keizer community and are important for our community to thrive holistically,
- 2. Using what is heard to create recommendations for action plan(s) for increasing community engagement and communication on progress in civic processes,
- 3. Acting on the values included in the Resolution for Justice, Equity, Diversity and Inclusion.

Tasks: To assist in developing action recommendations for community engagement in civic processes in the following areas:

- 1. Collaboration with Council, other city committees, commissions and neighborhood associations to increase active participation and recommend culturally responsive actions,
- 2. Collaboration with other organizations (historical/cultural/arts, business organizations, faith community, community based organizations, education, and additional sectors not usually included),
- 3. Collaborating in community opportunities to have conversation, celebration, relationship building,
- 4. Recommending additions or subtractions of national observances/ commemorative/heritage months,
- 5. Help develop metrics and yearly report on tasks identified and the data needed to better understand culturally responsive provision of services and public participation,
- 6. Assist in identifying leaders and build leadership capacity of underrepresented and underserved communities.

Membership: The Committee shall consist of nine voting members. Two (2) members shall be Keizer City Councilors to be appointed by the Mayor and announced at a regularly scheduled Council meeting, six (6) citizen-at-large members and one (1) youth member who is under 19 years of age at the date of appointment. Appointed members will be expected to think broadly in terms of how issues of racism, sexism, ableism, and other discriminatory and prejudicial biases that impact all residents in Keizer. The Committee will be staffed by a non-voting staff liaison to be appointed by the City Manager.

Term of Office: Each Councilor member shall be appointed for a two-year term by the Mayor pursuant to the Council Rules of Procedure. Each non-Councilor member shall be appointed for a three-year term, except for the initial terms. The initial terms of the non-Councilor members shall be staggered so that not more than three will expire in the same year. Each Councilor shall directly appoint one citizen-at-large member following the same process as appointments of Volunteer Coordinating Committee members. The Mayor shall appoint the youth member. Members may be reappointed.

Chair and Vice-Chair: The Committee will elect the Chair and Vice-Chair at the first meeting of each calendar year.

Meetings: Members of the Committee shall establish a regular meeting date and shall meet as deemed necessary by the Chair. All meetings of the Committee shall follow Robert Rules of Order Newly Revised and the Oregon Public Meeting Laws.

Attendance: It is the duty of each member to attend at least 75% of the meetings each calendar year. When a member is unable to attend a meeting, the member shall notify the Chair. Members of the Committee may be removed by a two-thirds majority vote of the City Council.

INTRODUCTIONS: Each member introduced themselves and described their interest in this committee. Laura Reid shared information about Dr. Taylor and Kacey McCallister.

ELECTION OF CHAIR AND VICE CHAIR: Dr. R. W. Taylor, Anthony Rosilez and Claire Snyder were nominated to serve as chair. With no further nominations, nominations were closed. Taylor received one vote and Rosilez and Snyder each received three. At this point Kacey McCallister joined the meeting. Candidates introduced themselves to him. A tie-breaking vote was taken with Rosilez receiving the majority of the votes. Claire Snyder was nominated to serve a Vice Chair. With no further nominations, nominations were closed and Ms. Snyder was elected by unanimous consent. Anthony Rosilez will serve as Chair and Claire Snyder as Vice Chair.

DETERMINATION OF SCHEDULED MEETING DATES: Committee members discussed options. Laura Reid moved that the Community Diversity Engagement <u>Committee meet on the first Tuesday of each month beginning March 2022. Kim</u> <u>Freeman seconded. Motion passed as follows</u>: Rosilez, Snyder, Toomes, Freeman, McCallister, Music, Reid and Starr in favor with Taylor absent.

Members agreed to meet at 6 p.m. for no more than 90 minutes.

COMMITTEE PURPOSE, TASKS AND GOALS: Committee members discussed possible economic development priorities through the Marion County Economic Prosperity Initiative such as tournament town sports facilities development and support, a revitalization plan for public investments (plaza, focal points, River Road/Lockhaven reconfiguration), food truck pod on City owned property, preparation of City owned properties for possible sale/development, consultant services to market City owned property for economic development or to create an urban renewal district, small

business grants/loans, consultant services for employment land urban growth boundary expansion, and small business loans. Additional discussion took place regarding revitalizing neighborhood associations, holding meetings in locations other than at City Hall and at times that don't interfere with family meal times, organizing Keizer's 40th Birthday celebration, developing a mini-leadership program to assist in identifying leaders and give them support, diversifying committee membership, educating people on how they can get involved and make a change, providing trainings with guest speakers through work sessions, hiring a community engagement consultant and budget.

Finance Director Tim Wood explained that the committee is an advisory group to Council and that he hoped that during the next few meetings the committee could determine what it needs so that those needs can be addressed by the Budget Committee.

Chair Rosilez urged committee members to focus on a few items and complete them rather than having many ideas and not completing any. He suggested the following **HOMEWORK**: Members should:

- Think about what they want to accomplish this year and come up with a mission that aligns with the purpose.
- Come up with suggestions on possible meeting locations other than City Hall.

APPEARANCE OF INTERESTED CITIZENS

Roland Herrera, Keizer, commended the committee and expressed gratitude for their commitment.

Joey Cappelletti, Keizer, urged committee members to contact him if they want suggestions from the community so that he can publicize that request in the Keizertimes.

STAFF LIAISON REPORT – City Demographic/Current Outreach: Finance Director Tim Wood referred to his staff report and pointed out that Keizer is becoming much more diverse. He indicated that he would send the Annual DEI Report from Beaverton to committee members for their information, and reviewed Keizer demographics, current outreach efforts and national observances and commemorative months.

Chair Rosilez announced that Claire Snyder had resigned from her position on the committee due to concerns regarding the event at Volcano Stadium.

VOLUNTEER APPRECIATION: Soraida Cross from the Volunteer Coordinating Committee thanked committee members for their volunteer efforts, dedication and commitment to the City and distributed cookies as a token of appreciation.

APPEARANCE OF INTERESTED CITIZENS:

Carrie Brown, potential candidate to fill the Snyder vacancy, introduced herself and explained why she wanted to serve.

Ramiro Navarro, Jr., introduced himself stating that he was looking forward to seeing what the committee would do.

Mayor Cathy Clark thanked the committee for the work they do, urged everyone to watch the April 4 Council meeting to learn more about the tribal nations, and asked the committee to focus on the tribal nations in the future.

ADOPTION OF MISSION STATEMENT: Exists to strengthen our community through active listening in order to strengthen and encourage civic engagement, understanding and empowerment and to advise the city council on issues that are critical to connecting our community. Following lengthy discussion, committee members agreed to add the following after the word 'Exists': "to foster justice, diversity, equity and inclusion and".

Laura Reid moved to adopt the following Mission Statement: "The committee exists to foster justice, equity, diversity and inclusion and to strengthen our community through active listening in order to strengthen and encourage civic engagement, understanding and empowerment and to advise the city council on issues that are critical to connecting our community." and that this statement would be a living guideline and subject to changes as needed. Shaney Starr seconded.

Kim Freeman suggested that the committee wait to adopt the Mission Statement until all committee members were present. <u>Reid and Starr withdrew their motion/second.</u>

Adoption of the Mission Statement was postponed to the next meeting.

ADOPTION OF 2022 GOALS: Discussion took place regarding various goals. It was suggested that some of the 'Listening Sessions' be held at Neighborhood Association meetings. Tim Wood explained that the proposed observances were taken from a list at the Library of Congress but that the Committee could recommend others as well.

Niveah Music offered the following Land Acknowledgement: "We are gathered on land of the Kalapooya, Confederate tribes of the Grand Ronde, the Confederated tribes of the Siletz Indians, and the Ahantchuyuk whose relationship with this land continues to this day. We offer gratitude for the land itself and for those who have lived on it for generations. We acknowledge that our city's history, like many others, is fundamentally tied to the first colonial developments in Oregon. Finally, we respectfully acknowledge and honor past, present and future indigenous citizens of Keizer.

With a genuine desire for collective healing and understanding, we offer this land acknowledgement to respectfully recognize the land and its indigenous people. The acknowledgement recognizes that lasting progress begins and continues with a growing understanding of harms, and works to challenge the legacies of colonialism in order to move forward in the true spirit of community." No action was taken.

Shaney Starr suggested that in order to determine what Council expects from the committee, a Joint Work Session be scheduled for June 13. It was noted that although the goals would probably shift and change, the committee needs them as a place to start. The committee is creating itself as it figures out the goals.

Adoption of the 2022 Goals was postponed pending adoption of Mission Statement.

DEVELOPMENT OF EQUITY AGREEMENTS: *Stay engaged, Listen to understand, Speak truth responsibly, Expect and accept non-disclosure, Be willing to do things differently and experience discomfort, Confidentiality.* Shaney Starr recommended that the following be included in the Equity Agreements: 'Commit to hold people in positive regard' and 'Recognize intent vs. impact'. R.W. Taylor suggested that adoption of the Equity Agreements be postponed to the next meeting.

<u>Shaney Starr moved to accept the proposed Equity Agreements including 'Commit to</u> <u>hold people in positive regard' and 'Recognize intent vs. impact'. Kim Freeman</u> <u>seconded. Motion passed as follows</u>: Rosilez, Toomes, Freeman, Music, Reid and Starr in favor, with Taylor opposed, McCallilster absent and one position vacant.

REVIEW CITY EQUITY STATEMENT (on City website): Postponed to next meeting. **COMMITTEE PRESENTATION ASSIGNMENTS:** Postponed to next meeting.

RECOGNITION OF APRIL OBSERVANCES: Postponed to next meeting.
