PROPOSED MOTION:

I move the City Council adopt Resolution R2022-____ Forming Tepper Crossing Street Lighting Local Improvement District.

AND

I move the City Council adopt a bill for an Ordinance Spreading Assessments to Tepper Crossing Street Lighting Local Improvement District.

I. SUMMARY:

On June 21, 2022 the City Council adopted Resolution R2022-3298 declaring the City's intent to initiate Ryden Forest Street Lighting Local Improvement District and directing the City Engineer to make a survey and file a written report with the City Recorder. On July 18, 2022 the City Council approved the City Engineer's report and set a public hearing to consider remonstrances to the project and objections to the proposed assessments. On July 22, 2022 the developer of the subdivision notified the City of a change of name for this subdivision. The new name is Tepper Crossing. Notice of public hearing stating the intention to form the district and to assess for the lighting improvements was mailed to the property owners as required under City of Keizer Ordinance 94-278.

II. BACKGROUND:

A. New subdivisions are required to establish a lighting district as part of the City's development code.

- B. Each district is assessed annually the cost to provide lighting (electricity) for their specific district for the previous year.
- C. Notice of the Public Hearing was mailed to the property owners and published in the Keizertimes.

III. CURRENT SITUATION:

- A. This is a 14-lot subdivision currently being developed.
- B. There is no lighting within this new subdivision.
- C. As outlined in the Engineer Report, 2 street lights will be mounted on new poles in the subdivision.
- D. A Public Hearing has been scheduled with notice sent for formation of this District.

IV. ANALYSIS:

- A. <u>Strategic Impact</u> The addition of a street lights will add to overall safety.
- B. <u>Financial</u> The City initially pays the street lighting expense to the utility company as it is billed throughout the year. The operating costs of the lights is then billed to the property owner on an annual basis, thereby recovering the City's cost for bills paid throughout the year. All funds are budged through the Utility Fund.
- C. <u>Timing</u> With the passage of the Resolution, Tepper Crossing will be formed. The Ordinance will allow the assessments to be spread to the District in the following year.
- D. <u>Policy/legal</u> The initiation of the district, the adoption of the City Engineer Report, and setting of public hearing meets the requirements outlined in City Ordinance 94-278.

ALTERNATIVES:

- A. Adopt the Resolution Forming the Tepper Crossing Street Lighting District.
- B. If no action is taken, the formation of the District will not move forward.
- C. If the Resolution is adopted, the Ordinance Spreading the Assessments should then be adopted.

RECOMMENDATION:

Open the public hearing to first consider oral objections and written remonstrances to formation of Tepper Crossing Street Lighting Local Improvement District. If valid remonstrances of the owners of two-thirds of the land to be specially assessed for the lighting district are presented to the Council at the public hearing, close the hearing and suspend formation of the district for six months. If remonstrances are not received, close the public hearing and consider adoption of the Resolution forming the lighting district. If Council forms the district, consider adoption of the proposed assessment Ordinance.

SUBJECT: KEIZER PUBLIC ART DISPLAY AREAS

PROPOSED MOTION:

I move the City Council add the two northernmost acoustic panels on the east and west walls of the City Council Chamber to the list of places the Keizer Public Art Commission is allowed to hang and rotate City-owned art.

I. **SUMMARY:**

The Keizer Public Art Commission (KPAC) has previously been given authority to program art pieces in the two City Hall hallway galleries and the "Living Room", which is the area between the Police Department, the other City Hall Offices, the entrance, and the City Council Chamber. KPAC would like to be able to hang art pieces in the City Council Chamber on the two northernmost acoustic panels on the east and west walls in the City Council Chamber.

II. BACKGROUND:

- A. When KPAC was formed they were given authority to designate the locations of art work as approved by the City Council. The City Council had previously granted them authority to program the Living Room and the hallway galleries. The City Hall Council Chambers was not included.
- B. KPAC displays both the City's permanent collection and temporary exhibitions by local artists. Generally, the temporary displays of artwork are in the hallway galleries. The city's permanent collection is typically those pieces in the Living Room.

III. CURRENT SITUATION:

A. KPAC moved artwork around the Living Room and hallway galleries. KPAC continues to purchase artwork each year. As additional pieces are purchased on behalf of the city, the need for rotation and reprogramming of the spaces will become greater.

B. There are two landscape pieces that KPAC would like to hang in the Council Chamber at this time. They would like authority to program the two northernmost acoustic panels on the east and west walls of the Keizer City Hall Council Chamber.

IV. ANALYSIS:

- A. <u>Strategic Impact</u> This action has no impact on the council's short or long-term goals.
- B. <u>Financial</u> No financial impact.
- C. <u>Timing</u> KPAC has moved artwork within the previously approved spaces in which they are approved for programming. There are two pieces they would like to hang in the council chambers at this time.
- D. <u>Policy/legal</u> The City Council has granted KPAC the discretion to move art in the City Hall Living Room and hallway galleries. The ordinance establishing KPAC requires the City Council to authorize other locations for which KPAC can display art.

ALTERNATIVES:

- A. Recommended Action Allow KPAC to determine art to be hung in the two northmost acoustic panels on the west and east sides of the Keizer City Council Chambers.
- B. Take No Action Without action, KPAC will still have the Living Room and hallway galleries in which to hang and rotate art work.

RECOMMENDATION:

Staff recommends that the Council include the two northernmost acoustic panels on the east and west walls of the Council Chamber to be included in the list of spaces for which the Keizer Public Arts Commission is allowed to hang and rotate City-owned artwork.

Several cities are planning to appeal this and they are asking for support from other cities to join in this effort. He clarified that there is no objection to the general purpose or concept behind the rules, but the detail and mandatory requirement is based not on legislative action but on a simple executive order by the governor and seems like state overreach.

Attorney to move forward to join other cities to appeal the recent Climate
Friendly and Equitable Communities Rules adopted by the DLCD subject
to formal approval by the Council at any joint appeal agreement.
Councilor Reid seconded.

Mayor Clark offered a friendly amendment to change DLCD to LCDC (Land Conservation and Development Commission) which is the body that adopted the rules. Councilors Smith and Reid accepted the amendment.

Mayor Clark provided details about what other cities have done towards this effort and the effect of the revisions as proposed by LCDC.
