WHEREAS, in 1977, the International Conference on Discrimination Against Indigenous Populations in the Americas, sponsored by the United Nations, began to discuss replacing Columbus Day in the Americas with a celebration to be known as Indigenous Peoples' Day; and,

WHEREAS, The United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) was adopted by the General Assembly on Thursday, 13 September 2007, and the United States endorsed the United Nations Declaration on the Rights of Indigenous Peoples (the "Declaration") on 16 December 2010; and,

WHEREAS, the UN Declaration begins by:

"Affirming that indigenous peoples are equal to all other peoples, while recognizing the right of all peoples to be different, to consider themselves different, and to be respected as such,

Affirming also that all peoples contribute to the diversity and richness of civilizations and cultures, which constitute the common heritage of humankind,

Affirming further that all doctrines, policies and practices based on or advocating superiority of peoples or individuals on the basis of national origin or racial, religious, ethnic or cultural differences are racist, scientifically false, legally invalid, morally condemnable and socially unjust"; and

WHEREAS, in August 1953, Termination to strip the Tribal nations of the United States of their identity, force assimilation into mainstream American culture, and deny the rights of self-determination enshrined in the 374 United States – Indian treaties established from 1778 to 1872, was begun when the 83<sup>rd</sup> Congress approved House Concurrent Resolution 108, which directed the government "as rapidly as possible, to make the Indians within the territorial limits of the United States subject to the same laws and entitled to the same privileges and responsibilities as are applicable to other citizens of the United States, and to end their status as wards of the United States, and to grant them all of the rights and prerogatives pertaining to American citizenship; and,

WHEREAS, in 1977, the first Restoration of Oregon Tribes was achieved with recognition of the Siletz Tribe, and has been completed for nine Tribes which have been persistent in rebuilding their nations and controlling their own destiny; and.

WHEREAS, the people of the city of Keizer, recognize and acknowledge that the city is built upon the homelands of the peoples of the Confederated Tribes of Siletz Indians and Confederated Tribes of the Grand Ronde and further recognize and acknowledge the many contributions made to our community through their knowledge, labor, spirituality, technology, science, philosophy, arts and culture.

NOW, THEREFORE, I, Cathy Clark, Mayor of the City of Keizer, together with the Keizer City Council assembled in Regular Session, do hereby proclaim October 10, 2022 as

#### INDIGENOUS PEOPLES DAY

AND FURTHER proclaim that the City of Keizer shall continue its efforts to promote the prosperity, dignity, respect, and well-being of Indigenous persons in our community and shall encourage businesses, organizations and public institutions to do the same.

### **PROPOSED MOTION:**

## I. SUMMARY:

Staff is recommending the City Council adopt seven resolutions authorizing supplemental budget adjustments for Fiscal Year 2022-23. The adjustments are:

- To recognize and appropriate \$150,000 of additional revenue in the Sewer Fund as the result of the sewer rate increase that is effective January 1, 2023.
- To recognize and appropriate \$125,000 and \$375,000 of additional working capital in the Water and Stormwater for the purchase of a Vac Con service vehicle that was originally budgeted in Fiscal Year 2021-22 but due to supply delays was not received until Fiscal Year 2022-23.
- To recognize and appropriate \$450,000 of additional working capital in the Water Facility Fund to provide appropriations for capital projects not completed during the prior fiscal year.
- To recognize and appropriate \$450,000 of additional working capital in the Street Fund to provide appropriations for capital projects not completed during the prior fiscal year.
- To transfer from contingency \$395,000 to personnel services in the American Rescue Plan Act Fund to provide appropriations for the accrued leave cash out.
- To recognize and appropriate \$55,000 of additional working capital to provide for the purchase of police vehicles in the General Fund Police Department.

To recognize and appropriate \$180,000 of additional working capital in the Parks Services
Fund to provide appropriations for capital projects not completed during the prior fiscal
year.

# II. BACKGROUND:

- A. Oregon Budget Law provides that a supplemental budget may be adopted when an occurrence or condition that was not known at the time the budget was prepared requires a change in financial planning.
- B. When a supplemental budget will adjust fund expenditures by 10 percent or less the supplemental budget may be adopted by resolution at a regularly scheduled meeting of the City Council. The budget committee is not required to be involved.
- C. When a supplemental budget will adjust fund expenditures by 10 percent or more, then a public hearing must be held and public comment taken before adoption of the resolution authorizing the supplemental budget. The budget committee is not required to be involved.

# III. CURRENT SITUATION:

- A. Staff is proposing seven supplemental budgets for Fiscal Year 2022-23
  - 1. To recognize and appropriate \$150,000 of additional revenue as the result of the sewer rate increase that is effective January 1, 2023. The biannual Water and Wastewater Task Force reviewed the cost of service analysis and recommended a system wide rate increase of 5% for both calendar year 2023 and 2024. The cost of service analysis specific to providing sewer services to the City of Keizer recommended a 5.6% and 5.2% increase for calendar years 2023 and 2024, respectively. This adjustment is to recognize the increase attributed to Fiscal Year 2022-23.
  - 2. To recognize and appropriate \$125,000 and \$375,000 of additional working capital in the Water and Stormwater for the purchase of a Vac Con service vehicle that was originally budgeted in Fiscal Year 2021-22 but due to supply delays was not received until Fiscal Year 2022-23.
  - 3. To recognize and appropriate \$450,000 of additional working capital in the Water Facility Fund to provide appropriations for capital projects, specifically the Meadows Well Filter Plant addition not completed during the prior fiscal year.
  - 4. To recognize and appropriate \$450,000 of additional working capital in the Street Fund to provide appropriations for capital projects, primarily street resurfacing projects, not completed during the prior fiscal year.
  - 5. To transfer from contingency \$395,000 to personnel services in the American Rescue Plan Act Fund to provide appropriations for the accrued leave cash out.

- 6. To recognize and appropriate \$55,000 of additional working capital to provide for the purchase of police vehicles in the General Fund Police Department.
- 7. To recognize and appropriate \$180,000 of additional working capital in the Parks Services Fund to provide appropriations for capital projects not completed during the prior fiscal year, specifically ADA upgrades, field work, lighting and tree work throughout the park system.

# IV. ANALYSIS:

- B. <u>Financial</u> The financial impact of this request is to:
  - 1. Increase revenues and materials and services appropriations in the Sewer Fund by \$150,000.

  - 3. Increase revenues and capital outlay appropriations in the Water Facility Fund by \$450,000.
  - 4. Increase revenues and capital outlay appropriations in the Street Fund by \$450,000.
  - 5. Reduce contingency and increase personnel services appropriations in the American Rescue Plan Act Fund by \$395,000.
  - 6. To increase revenues and capital outlay appropriations by \$55,000 in the General Fund Police Department.
  - 7. Increase revenues and capital outlay appropriations by \$180,000 in the Park Services Fund.
- C. <u>Timing</u> In order for the supplemental budget to be reflected in Fiscal Year 2022-23 the resolutions must be adopted by June 30, 2023.

#### **PROPOSED MOTION:**

"I move the City Council adopt Resolution R2022-\_\_\_ Exemption of McLeod Avenue Storm Drain Rehabilitation Contract from Competitive Bidding and Awarding Contract to Michels Trenchless Inc."

# I. SUMMARY:

Ordinance No. 2005-519 requires that the City must attempt to obtain at least three quotes using the Informal Solicitation process. The type of work described below is specialized and to avoid further delay and the expense of performing a formal bidding process, staff is requesting an exemption from the competitive bidding process and authorization for the City Manager to enter into the contract with Michels Trenchless Inc.

# II. BACKGROUND:

During routine video inspection of the storm drain system a 100-foot section of damaged 36" diameter concrete pipe was identified in the line on McLeod Avenue NE. Staff considered the options for repairing the damaged section of pipe and determined that the preferred option is to have a cured-in-place liner installed in the existing pipe as opposed to replacing the pipe.

# **III.** CURRENT SITUATION:

The existing pipe has longitudinal cracking along a 100-foot section of the pipeline that will ultimately result in the failure of the pipe if repairs are not made. This pipeline runs between two houses which makes replacement more difficult and costly.

# IV. ANALYSIS:

A. **Strategic Impact** – There is no direct strategic impact with approval of this project.

- B. <u>Financial</u> Funds for this project are available in the City Council adopted Fiscal Year 2022/2023 Stormwater Fund budget
- C. <u>Timing</u> Approval of this request will allow repairs to be completed before the fall and winter rainy season.
- D. <u>Policy/legal</u> City Council approval is required to exempt the project from competitive bidding and award the contract.

# **ALTERNATIVES:**

- A. Adopt the attached Resolution authorizing the City Manager to enter into a contract with Michels Trenchless, Inc.
- B. Take No Action The pipeline will likely fail at some point in the future.

# **RECOMMENDATION:**

Staff recommends the City Council open the public hearing and take testimony. SUBJECT: REGULATION OF FIREWORKS ORDINANCE

### **PROPOSED MOTION:**

"I move that the Council adopt Ordinance No. 2022-\_\_\_\_ Relating to the Regulation of Fireworks Within the City of Keizer."

# I. SUMMARY:

Following the public hearing on September 6, 2022, Council directed our office to prepare a fireworks ordinance. The Ordinance is before the Council for consideration.

# II. BACKGROUND:

- A. The Council held a work session on this matter on August 8, 2022, followed by the public hearing on September 6, 2022.
- B. The Council is concerned that the use of illegal fireworks present a serious livability problem for the city's residents.
- C. In addition, the Council is concerned that during periods of high fire risk, the use of even legal fireworks present a dangerous situation.
- D. The Council directed our office to prepare an Ordinance with the following provisions:
  - 1. The ordinance prohibits the sale, possession, use or exploding of illegal fireworks at any time.
  - 2. The ordinance prohibits the sale, possession, use or exploding of all fireworks, legal or illegal, at any time a National Weather Service "Red Flag Warning" is in effect. A Red Flag Warning indicates high fire risk. The previous draft also

prohibited the sale or possession of legal fireworks during a Red Flag Warning. Council deleted that prohibition because the warnings could be suddenly imposed and prohibiting the sale or possession would be unfair and difficult to enforce.

- 3. The Ordinance prohibits the use of any fireworks after 10:00 p.m. until 10:00 a.m. the next day, except for New Year's Eve and July 4<sup>th</sup>.
- 4. The Ordinance also makes it a violation for the person who owns or controls property to allow a violation of any of the three restrictions above, namely, use/sale of illegal fireworks, use of any fireworks during Red Flag Warnings and use of any fireworks after 10 p.m. except for New Year's Eve and July 4th.

# III. CURRENT SITUATION:

- A. Fireworks use is negatively impacting livability for City residents. It affects veterans suffering from post-traumatic stress disorder, it causes distress for many pets, and it is disturbing for all types of residents. In addition, use of fireworks during high fire risk periods is dangerous.
- B. Current tools to deal with the problem are limited to criminal offenses or State Fire Marshall violations. Neither of those remedies have been useful tools in addressing the problem.
- C. Prohibiting illegal fireworks at all times and prohibiting legal fireworks during Red Flag Warnings and in the late evening may reduce the problem.

# IV. ANALYSIS:

- A. **Strategic Impact** None
- B. <u>Financial</u> None
- C. <u>Timing</u> Addressing this issue now will give time to educate the public before the New Year's Eve or July 4<sup>th</sup> holidays.
- D. <u>Policy/legal</u> Providing a livability community is something that the City should strive to do. The addition of a municipal violation option provides a useful tool to address this problem.

#### **ALTERNATIVES:**

- A. The recommended alternative is to adopt the Ordinance relating to the regulation of fireworks.
- B. Direct staff to look at other solutions such as education-only campaigns or additional ways to use existing remedies.

C. Take no action. This alternative would likely result in continual livability impacts on the community.

# **RECOMMENDATION:**

Staff recommends that Council adopt the attached Ordinance.

On a personal note, Mr. Sangster thanked Keizer, City Staff and McNary students for assistance provided at the memorial held for his son-in-law.

PUBLIC COMMENT Kevin Cameron, Marion County Commissioner, shared information about the Marion County Reentry Initiative, Second Chance Breakfast on October 27, and asked that the City waive the fees for the rental of the Community Center.

> Rhonda Rich, West Keizer Neighborhood Association, provided a brief history of the Association's efforts to get a traffic calming device on Cummings Lane and a stop sign at Shoreline and Dearborn. She noted that the consulting firm that did the speed study makes no mention of the proximity of the Cummings Elementary and asked that the area around the school get the same attention that has been given to other neighborhood schools.

*Michael DeBlasi*, Keizer, suggested that Council reject the report from DKS Engineering related to the 4-way stop on Cummings at Dearborn and the speed table, and shared information on possible alternatives including speed cushions and offset speed tables.

Carolyn Holman, Keizer, complained that in spite of continued monitoring by the WKNA the traffic report for the Cummings/Shoreline /Dearborn area was not shared with the association prior to putting it on the Council agenda. She questioned the cost of the report vs. the cost of putting in a speed table and concluded her testimony with an invitation to the next WKNA meeting.

*Katherine Stone*, Keizer, explained that members of the Salem-Keizer community are having a petition drive to recall members of the School Board and invited everyone to attend the School Board meetings.

Paula Guiles, Keizer, distributed the Keizer Community Library Annual Report highlighting past and future efforts.

Mayor Clark noted written comments received from *Jimmy Jones*, Community Action Executive Director, Salem, Mid-Willamette Valley Community Action Agency seeking additional government appointed representatives to join the Board of Directors and *Jane Herb*.
