PROPOSED MOTION:

I move the City Council recommend approval of the application for a change of ownership for the Liquor License for Ocean Sushi & Teriyaki under the guidelines as established by ORS 471.178 and the Ordinances of the City of Keizer.

I. <u>SUMMARY</u>:

On October 24, 2022 the City received an application for a change of ownership for the liquor license for Ocean Sushi & Teriyaki located at 3843 River Road N, Keizer, Oregon. The application is for a Limited On Premises license. As required by Keizer Ordinance 2010-623 a public hearing was scheduled; notice was published and mailed to all property owners within 200 feet of the establishment. The Keizer Police Department has completed a background check on the applicant and has no reason to recommend denial of the application. In addition, the Keizer Planning Department finds the location of the establishment to be property zoned and has no additional comment on the application.

II. BACKGROUND:

- A. Keizer Ordinance 2010-623 includes guidelines for review of liquor license applications in the City of Keizer.
- B. The Ordinance states liquor licensees should promote, sell, and serve alcohol in a responsible manner which minimizes the risks associated with its use, and should work in a partnership with the community to improve community livability.

III. CURRENT SITUATION:

- A. A new owner has purchased the Ocean Sushi & Teriyaki business located at 3843 River Road N, Keizer Oregon.
- B. The Oregon Liquor Control Commission requires a new application be submitted for review by the local governing body.

IV. ANALYSIS:

- A. <u>Strategic Impact</u> N/A
- B. **<u>Financial</u>** The application requires a \$100 fee, which has been paid.
- C. <u>**Timing**</u> Upon a recommendation of approval, the applicant will finalize the liquor license application with the Oregon Liquor Control Commission.
- D. <u>Policy/legal</u> The review process for a liquor license application is outlined in City Ordinance 2010-623.

ALTERNATIVES:

- A. Recommend approval of the license application.
- B. If no action is taken, the Oregon Liquor Control Commission will have the authority to make a determination.

RECOMMENDATION:

Staff recommends the public hearing be opened to allow testimony from the applicant or other interested individuals and upon completion, the hearing be closed. It is further recommended the Council recommend approval of the application for Ocean Sushi & Teriyaki under the guidelines as established by ORS 471.178 and the Ordinances of the City of Keizer. This recommendation shall then be forwarded to the Oregon Liquor Control Commission for final approval.

PROPOSED MOTION:

I move the City Council adopt Ordinance No. 2022-____ Declaring a Lien Against Property Located at 866 Dearborn Avenue Northeast, Keizer, Oregon and Directing the City Recorder to Enter Such Lien in the Minor Lien Docket Pursuant to Ordinance No. 94-282 (Nuisance Abatement Procedure); Declaring an Emergency.

I. <u>SUMMARY</u>:

This matter is before the Council for public hearing under Nuisance Abatement Ordinance No. 94-282. The property in question, located at 866 Dearborn Avenue Northeast, Keizer, Oregon was in violation of City Ordinance and the property owner was given notice of such violations. The City performed a nuisance abatement to address solid waste and housing code violations at the property with the property owner's consent.

II. <u>BACKGROUND</u>:

- A. The property was in violation of City Ordinance and the property owner was given notice of such violations. There was a significant amount of solid waste, illegal fencing materials, and housing code violations within the home that needed to be addressed.
- B. After the owner failed to correct the violations, the City abated the nuisance by disposing of the solid waste materials and employed an electrician to make the electrical connections safe within the home and replace the heaters that had been removed. The total abatement costs, including the ten percent administrative charge is \$3,526.50. A copy of the invoice presented to the owner is attached. In addition, notice publication costs of \$71.00 increases the total costs to \$3,597.50.

III. CURRENT SITUATION:

- A. The property nuisance has been abated and the invoice has been sent to the property owner. The property owner has indicated they will be paying monthly payments to take care of the lien.
- B. Once Council has determined the correctness of the Statement of Costs and declares a lien against the property, the lien will be entered into the lien docket.

IV. ANALYSIS:

- A. <u>Strategic Impact</u> No strategic impact
- B. <u>Financial</u> The financial impact of this request is \$3,597.50. The nuisance abatement budget is sufficient to cover the cost and was used to pay for the disposal of solid waste and electrical costs.
- C. <u>**Timing**</u> Approval at this request will allow the City to place a lien on the minor lien docket to assure that City costs can be recaptured.
- D. <u>Policy/legal</u> Ordinance No. 94-282 (Nuisance Abatement Procedure) requires that City Council hold a public hearing to determine the correctness of the Statement of Costs and to declare a lien against the subject property.

"I move the City Council waive all fees for the December 10, 2022 Jingle Dash 5K Run/Walk and the Keizer Holiday Lights Parade."

I. <u>SUMMARY</u>:

The Keizer Chamber of Commerce is requesting the City Council authorize the annual Jingle Dash 5K Run/Walk and the Keizer Holiday Lights Parade event for 2022.

II. BACKGROUND:

A. In 1990, the City Council passed Ordinance 90-193 (An Ordinance Prohibiting Street Vendors) that prohibits the selling of any commodity or service upon any street, sidewalk or public right-of-way. There is a provision that allows for suspension of such regulations during a festival. The suspension is done by a City Council Resolution.

Keizer Holiday Light Parade

B. In 2004 the City Council passed Ordinance 2004-489, amending Section 2.203 of the Keizer Development Code (Ordinance No. 98-389), which regulates "Permitted Temporary Uses". This amendment affords Council discretion in authorizing "additional temporary uses" during a specific event or festival, and specifically allows for the council to authorize temporary signage in conjunction with a temporary use. The Development Code reads as follows:

> Additional Permitted Temporary Uses. The City Council may, by resolution, authorize additional permitted temporary uses during a specific event or festival. This may include setting forth reasonable types of uses, appropriate zones for such uses, temporary signs and any time restrictions the Council finds necessary to protect the health, safety and welfare of the Public. (KDC Section 2.203.04.E)

- C. The Jingle Dash 5K Run/Walk and the Keizer Holiday Lights Parade are significant community events which are beneficial to the citizens of Keizer and the surrounding communities. These activities are being organized under the leadership of the Chamber of Commerce.
- D. The events will take place on December 10, 2022 this year. The Keizer Chamber of Commerce submitted a packet of materials relating to the events for approval, a copy of which is attached.
- E. In addition to the permits, the Chamber specifically requests authority to place up to eight food trucks/carts at each of the following locations:
 - 1. Saint Edward Catholic Church
 - 2. Willamette Valley Bank
 - 3. Simonka House
 - 4. Coppercreek mercantile
 - 5. Remodeling by Classic Homes
 - 6. Keizer Chamber
 - 7. Chicken Shack on Sam Orcutt Way
 - 8. Farmers Insurance
- F. The application and temporary use permit fees is approximately \$465. The K23 coverage fee is approximately \$180.
- G. The City, as part of its sponsorship, typically waives fees. The Keizer Chamber of Commerce has requested a waiver of the fees.
- H. Typically, the City provides police and public works staffing for the parade. Those costs are estimated to be \$7,500 and were included in the budget.

III. <u>CURRENT SITUATION</u>:

- Ordinance No. 90-193 requires that the City Council, by Resolution suspend the regulations regarding vendors. A Resolution is attached for your consideration. This Resolution prohibits any interference with pedestrian, vehicular or parade traffic.
- B. The Keizer Development Code requires that the City Council, by Resolution, authorize permitted temporary uses during a specific event or festival.
- C. The Keizer Chamber of Commerce has requested temporary uses that are not allowed without permission, including the allowance of food trucks.
- D. To allow the Jingle Dash 5K Run/Walk and the Keizer Holiday Lights Parade events to take place as requested, the City Council needs to adopt a Resolution outlining the specific uses allowed during the events. The attached Resolution approves the request with conditions that imposed last year.

IV. <u>ANALYSIS</u>:

- A. <u>Strategic Impact</u> No strategic impact. This action brings the community together and benefits the citizens of Keizer and the surrounding communities.
- B. <u>Financial</u> If Council chooses to waive fees, the direct financial impact of this request is \$8,145 including police and public works staffing costs which have already been budgeted.
- C. <u>**Timing**</u> Adoption of the Resolutions will allow the Jingle Dash 5K Run/Walk and the Keizer Holiday Light Parade to occur on December 10, 2022.
- D. <u>Policy/legal</u> Allowing the events with or without a fee waiver is a Council policy decision.

ALTERNATIVES:

- A. Take No Action and the events do not take place.
- B. Adopt a Resolution with conditions to allow the events to occur and to allow the food trucks and parade as requested charging the Chamber for costs, or some of the costs.
- C. Adopt the attached Resolutions with conditions that allow the events as requested which includes the waiver of the fees.

RECOMMENDATION:

Council should adopt the Resolution authorizing a temporary suspension of the Ordinance prohibiting street vendors. Council should then adopt the Resolution authorizing temporary uses subject to conditions for Jingle Dash 5K Run/Walk and the Keizer Holiday Lights Parade.

The Council should then consider the matter of the fees and make a minute motion to formalize its intent.



ENTRY INFORMATION

Entries *must* be lit, they may be historical, humorous or modern in design, so long as they are in good taste and reflect the theme which is "." Those planning entries should remember that our audience focus and participation will mainly be children.

Entrants must observe the following established parade rules, regulations and entry criteria:

1. The entry application must be filled out completely and must contain a full description of the proposed entry.

2. Your staging and disbandment assignment will be *e-mailed* to by Wednesday, prior to parade day.

3. Non-parade vehicles will not be allowed to park in the staging areas. Horse Trailers, Flat Bed Trailers, etc will not be allowed to stay in the staging area.

4. Parade Check-in and staging areas will be open at 3:30 p.m.

5. All parade participants must be in position no later than at 4:45 pm to be judged or by 5:30 pm for non-competitive entries. The parade will begin at approximately 7:00 p.m.



EXHIBIT "A"

Design, Restrictions and Conditions

The City Council approves the proposed temporary uses, hours of operation, placement of food trucks/carts, and signage for the 2022 Jingle Dash 5k Run/Walk and 2022 Keizer Holiday Lights Parade as follows:

- 1. Except as set forth in this decision, the 2022 Jingle Dash 5k Run/Walk shall be routed, staged, disbanded, operated and conducted pursuant to the Special Event Permit application submitted by the applicant as approved by the Keizer Police Department and Public Works Department.
- 2. Except as set forth in this decision, the 2022 Keizer Holiday Lights Parade shall be routed, staged, disbanded, operated and conducted pursuant to the Special Event Permit application submitted by the applicant as approved by the Keizer Police Department and Public Works Department.
- 3. Except as noted below, the 2022 Jingle Dash 5k Run/Walk and the 2022 Keizer Holiday Lights Parade may have one (1) food truck/cart located at each of the following locations :
 - Saint Edward Catholic Church
 - Willamette Valley Bank
 - Simonka House
 - Coppercreek Mercantile
 - Remodeling by Classic Homes
 - Keizer Chamber
 - Chicken Shack on Sam Orcutt Way
 - Farmers Insurance

All food trucks/carts shall be placed on a parking lot or other hard surface area.

No food truck/cart may be placed without the property owner's permission. All food trucks/carts shall be subject to the conditions further described herein as well as the sign code. Such food trucks/carts may be placed no earlier than noon December 10, 2022 and must be removed no later than noon December 11, 2022 and may not be located on any public road or sidewalk. The exact site location is subject to approval by the Planning Director.

- 4. No electronic signs of any type are allowed, unless required by the Keizer Police Department or Public Works Department for safety reasons.
- 5. The 2022 Jingle Dash 5k Run/Walk and the 2022 Keizer Holiday Lights Parade may have four (4) banners not to exceed 32 square feet advertising the events. The locations of such banners must have prior approval of the Planning Director.

Such banners may be placed no earlier than November 22, 2022 and must be removed no later than December 12, 2022.

- 6. The 2022 Jingle Dash 5k Run/Walk and the 2022 Keizer Holiday Lights Parade may have a hand sign or flag located at the Focal Point. Such sign or flag may be placed no earlier than December 2, 2022 and must be removed no later than December 12, 2022. The hand sign or flag shall not exceed the allowable size as stated in the sign code.
- 7. Signs, banners, flags and balloons shall be placed to ensure there shall be no traffic interference or distraction, and if deemed to be a hazard by the Planning Director, shall be removed immediately upon notice. Balloons shall be placed in such a manner so as to not present a potential to damage light fixtures or landscaping.
- 8. No other signs are allowed.
- 9. No signs, flags, balloons or other items may be placed in the right-of-way, except for banners referenced in Section 5. No signs shall be placed on private property without the specific permission of the private property owner. Other than banners referenced in Section 5, placement of any sign in any public right-of-way or sidewalk easement shall cause the City to remove such signs immediately without notice. In such instance, the Keizer Holiday Lights Parade shall be billed for City staff time, including benefits.
- 10. If required under applicable regulations, any food vendor shall obtain a license from Marion County Environmental Health or similar county agency prior to operating.
- 11. Any food truck/cart or other vendor shall not obstruct pedestrian pathways, driveways or drive aisles and shall not create a traffic or safety hazard.
- 12. Any paper, cardboard, wood, or plastic containers, wrappers, or any litter or material is to be picked up by the vendor.
- 13. All food trucks/carts must remain capable of being moved at any time.
- 14. All activities shall comply with Keizer Police Department's direction and requirements of Keizer Fire District.
- 15. Any food truck/cart not removed by December 11, 2022 may be immediately removed by City staff without notice and the Keizer Holiday Lights Parade shall be billed for staff time at the hourly rate of staff person including benefits for removing the food truck/cart.

PROPOSED MOTION:

"I move the City Council adopt Resolution R2022-____ Amending Resolution R2021-3215 (Recognizing National Observances and Commemorative/Heritage Months) to add Older Americans Month and remove Irish-American Heritage Month, Law Day, Constitution Day and Citizenship Day."

I. <u>SUMMARY</u>:

The Community Diversity and Engagement Committee (CDEC) met on Thursday November 3, 2022 and made a motion to recommend that the City Council add Older Americans Month and remove Irish-American Heritage Month, Law Day, Constitution Day and Citizenship Day from the list of recognized National Observances and Commemorative/Heritage Months.

II. BACKGROUND:

- A. On September 7, 2021 the City Council adopted Resolution R2021-3215 Recognizing National Observances and Commemorative/Heritage Months. The resolution currently identifies 13 National Observances and Commemorative/Heritage Months that the City will formally recognize.
- B. Resolution R2021-3215 was amended at the September 19, 2022 City Council meeting to add Indigenous People Day.
- C. Recognition of National Observances and Commemorative/Heritage Months may include the following types of activities among others in the discretion of the City Manager:
 - i. Acknowledgement on the City's readers board,

National Observances and Commemorative Months

- ii. Acknowledgement on the City's website/social media with links to additional educational materials, and
- iii. Displaying education materials.
- D. Appendix "A" of Resolution R2021-3225 Establishing Community Diversity Engagement Committee identifies that the CDEC is tasked with "Recommending additions or subtractions of national observances/commemorative/heritage months."

III. <u>CURRENT SITUATION</u>:

- A. The Community Diversity and Engagement Committee met on Thursday November 3, 2022 and made a motion to recommend that the City Council add Older Americans Month and remove Irish-American Heritage Month, Law Day, Constitution Day and Citizenship Day from the list of recognized National Observances and Commemorative/Heritage Months.
- B. Older Americans Month is celebrated in May and is to encourage and recognize the countless contributions that older adults make to our communities.

IV. <u>ANALYSIS</u>:

- A. <u>Strategic Impact</u> This action supports the City's Statement of Values-Justice, Equity, Diversity and Inclusion Statement dated December 7, 2020.
- B. <u>**Financial**</u> There is no financial impact for adopting this resolution.
- C. <u>Timing</u> The next opportunity to recognize Older Americans Month is May 2023.
- D. <u>Policy/legal</u> City Council action is required to add Older American Month and remove Irish-American Heritage Month, Law Day, Constitution Day and Citizenship Day to the list of formally recognized National Observance and Commemorative/Heritage Months.

ALTERNATIVES:

- A. Amend the resolution to add Older Americans Month and remove Irish-American Heritage Month, Law Day, Constitution Day and Citizenship Day from the list of National Observances and Commemorative/Heritage Months adopted by the City Council.
- B. Take No Action The list of National Observances and Commemorative Heritage Months formally recognized by the City will remain unchanged.
