Dear City of Keizer officals, and whoever it may concern:

I am not sure who to turn to this ongoing issue but the problem is getting worse. I thank you for putting the detectives attention to the problems here. The problem today is not so much legal or law breaking at least what I can see. I asked to "lock the gate" which they have done partially for only the lunch hour. That actually made the problems worse like noise, yelling, grouping, litter, smoking and now they are even chasing pets with hurtful intention. The reason the "partial" gate locking is making the problem worse is because the students are retaliating and showing their power over the school by climbing over the locked fence while security is turning a blind eye. There are at least 20 kids climbing over the fence every day now. So the kids that are scaling the fence are the hoodlums that the school does't want on the school grounds during lunch time because they smoke, litter, and raise hell so they are, by turning a blind eye, actually sending the undesirable students to my neighborhood!

The solution is easy. Lock the gate permanently just like they did on Sandy and Robindale and stop using my neighborhood as a parking lot for the school. Everyone,

I am writing again to tell you how impressive Robert Johnson is. He is an excellent problem solver and has excellent follow-through. He is absolutely the best representation of a public employee that I have ever worked with.

I called Robert yesterday in regards to an injury that we had at the old Keizer school when one of our senior volunteers slipped on a wet sidewalk covered in crab apples. The crab apples were from two ornamental trees that hang over a sidewalk. ### **SUBJECT: Stormwater Discharge Control Ordinance Summary of Changes** 02/22/2022

As you may know, the Oregon Department of Environmental Quality issued a National Pollutant Discharge Elimination System (NPDES), Phase II General Permit (#102904) to the City of Keizer in November 2018. The General Permit, effective March 1, 2019 through February 29, 2024, conditionally authorizes the City to discharge stormwater from the municipal separate stormsewer system (MS4) to waters of the state.

As a condition of this permit, the City is required to implement and enforce an Illicit Discharge Detection and Elimination program. The program should detect and eliminate illicit discharges into the municipal separate storm sewer system (MS4), underground injection controls (catch basins with perforated pipes), and surface waters within the City's jurisdiction.

The updated Stormwater Discharge Control Ordinance that is before you, reflects the updated NPDES Permit requirements which are required to be implemented by **February 28<sup>th</sup>**, **2022**.

Below is a summary of major changes that are reflected in the updated Ordinance:

- 1. Section 9 Allowable discharges (pg. 9-11)
  - a) **Updated:** Individual residential car washing, was updated as allowable on private property only.
  - Rationale: The NPDES Permit states that car washing is only allowable if non-heated water without soap or chemicals are used. Enforcing this would pose a significant challenge to our staff. Therefore, allowing car washing on private property only, was the most feasible way to remain in compliance with the Permit (See next steps for more information).
  - b) **Removed:** Occasional non-commercial car washing (e.g. Charity car washes) were removed from allowable list.
  - ➤ Rationale: Again, the NPDES Permit states that car washing is only allowable if non-heated water without soap or chemicals are used. Enforcing this would pose significant challenges to our staff, so the removing charity car washing from the allowable list was the most feasible alternative (See next steps for more information).
  - c) **Removed:** Dechlorinated swimming pools, hot tub, spa or similar discharges were removed from allowable list.
  - Rationale: The NPDES Permit states that only dechlorinated pool water is allowable. Enforcing this would pose a significant challenge to staff time and budget. Therefore, removing dechlorinated pool water from the allowable list was the most feasible alternative.
- 2. Section 25 Violations

- a) Added: Mandatory penalties for violations or failure to comply with the Ordinance were added.
- > Rationale: The NPDES Permit requires an Escalating Enforcement Response Plan with progressively stricter responses in order to achieve compliance with the Ordinance.

Summary of proposed next steps to meet NPDES Permit Requirements:

- 1. Create a public education and outreach campaign to educate the community on pollution sources, non-allowable discharges, alternative behaviors to avoid pollution and illicit discharges and the City's online reporting tool.
- 2. Conduct outreach to community groups about the impact of car washing on the health of our waterways and the Ordinance update. Create charity car-washing tool kits for the public to check-out. Identify public areas without catch basins or surface waters, that would be ideal for hosting charity car washes.
- 3. Notify the public of IDDE program changes via the Consumer Confidence Report.

Here is list of frequently asked questions:

What is the MS4? The Municipal Separate Storm-Sewer System is the City-maintained stormwater conveyance system.

What is an illicit discharge? Anything other than stormwater that enters the MS4, UIC or surface water, can be considered an illicit discharge.

Why does it matter? When it rains, impervious surfaces like roads, roofs and parking lots collect water (stormwater) which collects in catch basins and storm drains. Storm drains send stormwater through pipes, unfiltered, to outlet to the nearest waterway. The buildup of stormwater pollution (vehicle fluids, fertilizers, pesticides, sediment, etc.) in our waterways harm wildlife, human recreation and potentially drinking water.

What are the most common illicit discharges investigated? Some of the most common violations that our staff encounter are dirt/materials in the ROW, vehicle fluids leaking or spilled during maintenance, rinsing paint and other contaminated wash water being rinsed directly into drains. Will we enforce on violations of Charity Car washing or Residential Car washing in the ROW? Our first year will be focused on educating the public about the impacts of car washing on our water ways and providing alternatives that prevent illegal discharges, as outlined by the NPDES Permit. What is the E&T response and enforcement philosophy? Our Enforcement Response Plan emphasizes education first, in most cases. However, we are required to implement an escalating Enforcement Response Plan that addresses repeat violations through progressively stricter responses in order to achieve compliance.
