I was interested to read in the Keizertimes and hear from a friend who is a resident on the street that was added to the route at the last minute. My interest stems from being active with the Gubser Neighborhood Association when previous changes were made. When the route was moved from Rockledge to Meadowlark and from Meadowlark to Mistwood the route had to be reviewed and approved either by the Police or Fire Department. Their purpose of review involved the best traffic flow for the position of the donation collection site and effective emergency access to the area as well. The Miracle of Lights group would find someone willing to be the collection site and would propose a route or work with the reviewing agency to determine a route. It put the responsibility of determination in the hands of those with responsibility and experience in working with the safe and effective movement of traffic. And that saves time for the council to do important matters that only they can do. I recall at the time of one of those moves the city agency hadn't been contacted according to an agreement that was in place and there were some real problems in finally coming up with an acceptable route for all involved.

I met you at a city counsel meeting in December when I testified about unleashed dogs in Keizer rapids park. We talked about this problem prior to that meeting. Since then my friend and I had mostly avoided walking in the park but had returned in mid-January. On Friday, January 28 we were walking in the park when at about 10:30 we observed a man and woman with an unleashed dog. They were well above the path and the man had golf clubs and appeared to be practicing. My friend told me that there was an unleashed dog but I should be okay if I stayed on the path and continued on up the hill while he stepped away for a few minutes and he would catch up to me. When he returned to the path the people and dog were closer to the path than they had been when I headed on up the hill. I heard my friend politely mention that the city ordnance and park rules required that the dog be on a leash. The man argued with my friend. My friend caught up to me and we were proceeding up the hill when the man came charging toward us swinging two golf clubs. By this time the woman who was with him was trying to get ahold of the dog to leash him. She called him "Mike" and tried to get him to go back. He got right in my face while swinging the clubs and he hit me on my arm a couple of inches above my wrist with the clubs. He then said "it was an accident" a couple of times when it was actually an assault. He also said that he doesn't follow mans' laws, he follows god's laws. I'm not aware of any law that makes it okay to assault someone. I did manage to get his picture.

I'm a 78 year old woman with balance issues and I carry a hiking stick to keep my balance on uneven ground and when I turn or stop walking. My friend walks with me to keep me safe from falling. We haven't been walking in the park since this happened. I would like you to call me at 503-931-7711 to discuss what can be done so I can be safe when I'm walking in the park.





Greetings,

The election result showed a substantial level of support for a public library in Keizer. We intend to maintain the level of functionality that we are currently providing. We were present at the City Council meeting where a motion to fund KCL at the level of \$60,000 per year was passed but we lack clarity from the City on the timing of the distribution.

At the December board meeting, the KCL Board of Directors approved the 2023 budget, as required by library bylaws. Sustaining operations at the current level (cardholders have increased from 300 to > 1200; book donations increased to 1000 books / month) requires a paid manager in addition to dozens of volunteers. We need to have verification of 2023 funding before signing a one-year contract with our half-time Library manager. Additionally, we need to issue a statement to our cardholders and visitors as soon as possible to assure them that the library will be open for one more year.

At this time, the KCL Board of Directors has no plans to sponsor another ballot issue.

We currently have reserve funds for approximately six months of operation.
