- **City of Wilsonville operates South Metro Area Regional Transit (SMART) agency**
- **SMART operates 1X Express Bus between Salem and Wilsonville with Salem Mass Transit District**

# **HB 2662: ODOT Study of WES Commuter Train Extension**

**Bill directs Oregon Department of Transportation (ODOT) to Study North Willamette Valley Extension of TriMet's Westside Express Service (WES) Commuter Train from Portland Metro Area southern terminus in Wilsonville to Salem/Keizer Metro Area, with Stops in Donald, Woodburn, Keizer and Salem**

# HB 2662: ODOT Study of WES Commuter Train Extension

## Key parties:

- ODOT Public Transportation Division, Rail Operations & Statewide Multimodal Network Unit
- WES sponsor TriMet
- WES operator Portland & Western Railroad
- Cities: Donald, Keizer, Salem, Wilsonville, Woodburn
- Transit Operators: Salem Mass Transit, SMART, Woodburn


# HB 2662: ODOT Study of WES Commuter Train Extension

- Study and document the various costs, benefits, land-use and operational issues
- Extend current rush-hour-only WES commuter train from the current southern terminus in Wilsonville to Salem, with potential stops in Donald, Woodburn and Keizer
- Work with public transit operators Salem Mass Transit, SMART, Woodburn for “last-mile” connections to/from train stations

# HB 2662: ODOT Study of WES Commuter Train Extension


## About WES:

- Began service in 2009, with 5 stops along the 14.7-mile run at the transit centers of Beaverton, Hall/Nimbus, Tigard, Tualatin and Wilsonville
- WES runs Monday through Friday during the morning and evening commute “rush hours”



# HB 2662: ODOT Study of WES Commuter Train Extension

- Use 30-mile portion of the 122-mile “Oregon Electric Railway” Willamette Valley passenger train route that operated 1908 - 1933
- Used now by short-line Portland & Western Railroad, a division of the Genesee & Wyoming Inc.



# HB 2662: ODOT Study of WES Commuter Train Extension

## Issues of Concern

- Lack of sufficient alternative, public-transit commute options along I-5 from Salem/Keizer metro area to greater Portland metro area
- Growing population continues to build traffic congestion on I-5, 99E, 99W and other roads
- ODOT plans to toll I-205 and I-5 in Portland metro area, and additional tolled highways over time

# HB 2662: ODOT Study of WES Commuter Train Extension

## Issues of Concern

- Major state/federal investments to improve highways
  - \$6-8 Billion for I-5 Columbia River Interstate Bridge
  - \$750+ Million I-5/I-84 Rose Quarter interchange
  - \$600+ Million I-205/Abernathy Bridge
  - \$600+ Million I-5 Boone Bridge
  - \$50 Million I-5/Aurora interchange
- **Commensurate investment in mass transit is needed**
