- > All: Keizer Rapids Park: Concern was voiced regarding fire hazards and remains of small fires in areas throughout the park. Robert Johnson explained that City staff works closely with Keizer Fire District. Last year they widened a fire access road for them and they have been training staff on the fastest route. Any time staff hears of a fire they assist immediately and make sure KFD has quick access so that they can stop fires before they get out of hand.

Debbie,

Thank you for contacting us. There is a legal graffiti wall on private property and it is frequently used. This has been going on for many years, and has some amazing artwork. We still get graffiti throughout the system. It's usually the random tags, the simple ones. We do spend a lot of our time on removing those tags. I would say the people who are into graffiti as art don't tag our parks, they do use the wall.

In the late 90's we had graffiti wall on our riverfront park and it was removed in the early 2000's when the park was revamped. From my understanding the wall was frequently used back in the day. But still didn't alleviate the graffiti.

We have had luck with murals throughout the city, they'll get little tags here and there. They are coated with the anti-graffiti coating and they don't seem to be tagged very often. When they are, it's easily cleaned up. But we have to put more anti-graffiti coating on. We also use the anti-graffiti coating on all of our restrooms built with concrete blocks.

I can't say for sure if the graffiti wall eliminates graffiti around town, it just gives those that want to create the art a place to do so. The wall isn't cleaned up, it's just covered over by the next person. Like all things, only the rule followers will use the wall.
