**APPEARANCE OF INTERESTED CITIZENS:** Katie Brady and Lisa Cejka with the Parks Board spoke about legal graffiti. They suggested some art options with the Skateboard Park or bridge by having something that's in the public eye so artists can showcase their art. They believe these considerations should come to the Arts Commission and they concurred. Lore Christopher would like the Homan's to speak at an Art Committee meeting. They would like to eventually partnership with the Keizer Art Association and Chamber or the next ArtFest.

**GALLERY DISPLAY SCHEDULE | August-September ~ Iris Festival/Keizer Fest Annual Display | October-November ~ Native American Heritage Month Display in the case:** still need something in the north and south galleries. | **December-January ~ Mid Valley Quilt Guild:** will reach out to art quilt folks as in the past.

**STUDENT/EMERGING ARTIST DISPLAY:** *Introduced out of order.* Commission discussed how we could get quite a few art pieces from these artists because they're small pieces.

**UTILITY BOX PAINTING UPDATE:** Adam Brown checked the two utility boxes on River Road and both are almost the same size. Aspect ratio obtained to submit painting and sees no barriers with box wraps. Planning to have one box at every intersection. Need artist to submit once we decide the program design. One person submitted abstract Iris information and Commission already accepted his design. They would like to see a sample.

Can also talk with the Keizer Art Association and include the McNary kids. They should have a few parameters like themes for craftsmanship. Kat Thoreson will compile something for next month.

**ROSALIE'S COWS SIGN & SCULPTURE – NEED TO ASK PARKS ADVISORY BOARD FOR RECOMMENDATION TO COUNCIL FOR PLACEMENT OF THE SIGN AND/OR**

**SCULPTURE:** Lore Christopher moved to table the Motions for items 6, 7, and 8 to the September 19<sup>th</sup> meeting. Kat Thoreson seconded. Motion passed as follows: Steen, Christopher, Thoreson, Squires, Bish, and Wood in favor with Reid absent.  
Lore Christopher moved to meet with Smith & Steel as fabricator and some other artists to determine if it's feasible to put 'Insta-Art' cows near the sign. Derek Bish seconded to explore the art of 'Insta-Art.' Motion passed as follows: Steen, Christopher, Thoreson, Squires, Bish, and Wood in favor with Reid absent.

**BLOOMBERG PHILANTHROPIES ASPHALT ART:** Commission discussed asphalt art on roadways, crosswalks, intersections, and vertical infrastructure that includes utility boxes. Project must improve roadway and bicyclist safety. Requirements are to make crosswalks more visible and must have broad community involvement. This is a competitive grant. Must have everything planned months in advance, such as cost and who will paint it. We can save \$350 per utility box. This can be an ongoing program. Felicia Squires will look further into this project.



# Rosalie's Silly Cows



The art display in the Verda/Chemawa roundabout is in honor and recognition of Rosalie Herber Moore, a Keizer pioneer who passed away in 2007 at age 89.

She and her husband Joseph operated the Keizer View Dairy and lived in Keizer's oldest home located on Verda Lane between Chemawa Road and Dearborn Avenue. They delivered milk door-to-door and raised cows and chickens on the property that was nicknamed "Keizer's Cows." Over her lifetime Rosalie was a farmer, a schoolteacher and an active Keizer resident.

Born April 9, 1918 in Murdo, South Dakota, Rosalie became a teacher at age 17 in South Dakota and married Joseph at age 20, relocating to Vancouver, Washington and eventually Keizer, where she spent the rest of her life. She worked for the Oregon School for the Deaf for 16 years, ultimately earning an Oregon teaching degree and a master's degree in education from Western Oregon University. After retiring from teaching, she taught Sunday school at Saint Edward Catholic church for many years.

Even though she was already in her 60's when Keizer was incorporated in 1982, she was an inaugural member of the Keizer Parks Advisory Board and contributed to the initial parks design and system for the City. When she retired from the Parks Board she was honored as a lifetime member emeritus.

Rosalie's volunteer efforts also included 4-H; Scouting; Keizer Pioneers; Daughters of the American Revolution; Business and Professional Women's Club; Daughters of Union Veterans of the Civil War; Keizer Art Association; Library Services Task Force; and the Keizer Heritage Foundation.

Rosalie is remembered as a feisty and funny lady who wouldn't take "no" for an answer. In 1997 she stated during a Keizertimes interview, "Lots of people think it's crazy to keep these silly cows. But I have no desire to sell the land...or the cows." And she didn't. Her land was left to family who eventually sold the land to a developer for multi-family homes.
