Councilor Smith moved that the Keizer City Council accept the resignation of Chris Eppley effective Monday, April 5, 2021, and that the City offer Chris Eppley a separation package which is to acknowledge his long length of service, approximately 21 years, his significant contributions to the community, and in response to concern regarding whether his rights were violated due to the release of information that was confidential, subject to attorney-client privilege at the time of that release; and the compensation shall include six months salary and 12 months health insurance unless he obtains other coverage before that date, in which case his insurance would end on that date; and in exchange for the salary and insurance there will be a release of claims and other provisions as recommended by the City's labor attorney.
