If the Operator is a corporation, the term Operator also includes each and every member of the corporation's Board of Directors whose directorship occurs in a period during which the Marijuana Retailer is in operation. If the Operator is a partnership or limited liability company, the term Operator also includes each and every member thereof whose membership occurs in a period during which the Marijuana Retailer is in operation.
