Applicant hereby applies to The City of Keizer for permission to construct a driveway approach/sidewalk at the permit address above. Driveway access normally includes the area from the edge of the public road to the property line.

The franchisee agrees to remove any construction that is determined by the City of Keizer not to meet standards. The applicant shall indemnify and save harmless the City of Keizer, its officers and employees from all suits and actions; or claims of any character brought because of any injuries or damages received or sustained by any person or property on account of the operations of said Applicant, their subcontractors, or the employees of either; or on account of or in consequence of any neglect in safeguarding the work; or because of any act or omission, neglect or misconduct of said Applicant. Applicant declares that they are the franchisee with rights associated with this permitted construction. This permit is issued subject to the terms and provisions contained herein, attached hereto, and the Design Standards and Construction Specs located on the City's website at <u>www.keizer.org</u> under the Public Works Department page and is accepted by the Applicant subject to said terms.

<u>Start of work shall indicate the Applicant accepts and approves the terms and provisions contained herein, including the special provisions and the City of Keizer's Design Standards.</u> Permits for construction expire one (1) year from date of issue. The City of Keizer and franchisee also acknowledge the terms of the franchise agreement between the parties.

CONSTRUCTION REQUIREMENTS

The driveway approach/sidewalk shall be constructed in accordance with the City of Keizer Standards (driveway approach/sidewalk standards below) and other requirements of the City of Keizer Public Works Department. A copy of the permit shall be on site during construction. Construction of said approach/sidewalk must be completed ONE YEAR from the date of permit approval. If construction is not completed by this date, this permit shall be void. The driveway approach/sidewalk shall be maintained as approved and shall not present a hazard for pedestrian, road or driveway users. (Office use only) Approval location of driveway approach/sidewalk:

STANDARDS & ADDITIONAL SPECIAL PROVISIONS:

All areas within the public right-of-way disturbed by the project shall be restored to the same or better condition.

NON-CURBED STREETS: permits require the applicant to indicate the driveway's position relative to landmarks such as roads, other driveways, fence lines, power poles, etc. on the <u>attached site plan</u>. Applicant must provide site plan prior to permit issuance. Applicant must also mark the proposed access in the field at the road with stakes, flagging, or paint so the inspector can readily locate it. $W = \frac{24'}{Maximum}$ $R = \frac{10'}{20}$ $A = \frac{90^{\circ}}{20}$
