The Oregon Department of Environmental Quality (DEQ) has issued coverage under the NPDES Municipal Separate Storm Sewer System (MS4) Phase II general permit to the City of Keizer as of March 1, 2019. You must use the Annual Report form provided by DEQ and submit one hard copy and one electronic copy, including any supplemental information on a portable electronic storage device or via email (link to the Annual Report form: <https://www.oregon.gov/deq/FilterPermitsDocs/ms4ph2report.docx>).

Please let us know if we can provide technical assistance and/or answer any questions as you plan for and conduct your work to comply with the conditions in the permit that help in our collective efforts to protect Oregon's waterways.


